RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **M.J. COLLEGE, PLOT NO.- 2038, 2039/1, STREET/ROAD - KHOHKA, JUNWANI ROAD, VILLAGE - BHILAI, POST OFFICE - NEHRU NAGAR, DIST-DURG-490020, CHHATISGARH** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRCAPP191/146/B.ED./2011/76410-76413 dated 15-03-2011.

2. **AND WHEREAS**, Revised Recognition order was issued to **M.J. COLLEGE, PLOT NO.- 2038, 2039/1, STREET/ROAD - KHOHKA, JUNWANI ROAD, VILLAGE - BHILAI, POST OFFICE - NEHRU NAGAR, DIST-DURG-490020, CHHATISGARH**, vide order No. WRC/APP191/2015/139090-141747 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 200 students for four basic units of (50 students each) from the academic session 2015-2016.
3. **AND WHEREAS**, Compliance was Submitted on 04.03.2016 as per regulations 2014.
4. **AND WHEREAS**, the matter was placed in 293rd Meeting held on June, 12-14 2018 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 31.05.2015 was issued and the institute replied on 28.10.2015.

The institute is running the B.Ed. course. It has submitted the staff profile of one HOD and 28 Asst. Professors against a requirement of 1+30. All the Pages of the staff profile are not approved by the affiliating body and not submitted in original. Staff Profile should be sent in NCTE Proforma (attached). The institute needs to submit additional FDRs for 4 Lakhs as required under NCTE Regulations. Further, FDRs for 5 & 3 Lakhs have matured in 2016. These should be sent for renewal in Joint name.

Hence, Show Cause Notice be issued on the above points. Reply should be submitted within one month."

5. **AND WHEREAS**, The Show Cause Notice was issued to the institution on 22.06.2018 as per decision, and its reply received on 29.07.2019 & 03.11.2019 from the institution.
6. **AND WHEREAS**, the matter was placed in 346th Meeting held on 28-30 July 2021 of WRC and the Committee decided that.

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:
This is a RPRO case and same was remanded back by the Appellate Authority.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for B.Ed. course be restored.

Committee also decided to return additional FDRs of Rs. Eight lakhs to the institution."

7. NOW THEREFORE, recognition dated 15-03-2011 and revised recognition order dt. 31.05.2015 issued to the institution viz **M.J. COLLEGE, PLOT NO.- 2038, 2039/1, STREET/ROAD - KHOHKA, JUNWANI ROAD, VILLAGE - BHILAI, POST OFFICE - NEHRU NAGAR, DIST-DURG-490020, CHHATISGARH** for B.Ed. course is hereby restored permitting the total annual intake of 100 (two unit of 50 students).
