RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **SHRI DHANESHWARI MANAV VIKAS MANDAL, COLLEGE OF EDUCATION, HATTA, TQ.BASMAT, HINGOLI, MAHARASHTRA** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course, with an annual intake of 100 students (Two basic unit of 50 students each) vide order No. WRC/5-6/123199/2004/7008-13 dated 25.08.2005.

2. **AND WHEREAS**, Revised Recognition order was issued to **SHRI DHANESHWARI MANAV VIKAS MANDAL, COLLEGE OF EDUCATION, HATTA, TQ.BASMAT, HINGOLI, MAHARASHTRA** vide order No. F.No. WRC/APW01121/123199/2015/140661-140675 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of (50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, Compliance was not submitted as per regulations 2014.

4. **AND WHEREAS**, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. **AND WHEREAS**, a Show Cause notice was issued to the institution on 23-02-2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

6. **AND WHEREAS**, the reply of show cause notice was not submitted by the institution.

7. **AND WHEREAS**, the matter was placed in 316th Meeting held on August 27-28, & September 03rd 2020 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

8. **AND WHEREAS**, a Show Cause Notice was issued to the institution on 28.09.2020 as per decision of WRC, and its reply not received by the institution.

9. **AND WHEREAS**, the matter was placed in 322nd Meeting held on November 23-24, 2020 of WRC and the Committee decided that.

"... The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and

Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 25.08.2005 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
2. The institution has not shifted the institution in its own premises till date.
3. Accordingly, Show Cause Notice was issued to the institution on 28.09.2020.
4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be WITHDRAWN under section 17 (3) of the NCTE Act from the next academic session 2021-22"

10. **AND WHEREAS**, the Withdrawal order was issued to the institution on 11-12-2020.
11. **AND WHEREAS**, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 13447/2021 dt. 29.11.2021 the operative part is produced here below:-

"...In view of the above, there is no impediment of the petitioner participating in the counselling, and admitting students for the academic session 2021-22. The NCTE is directed to reflect the status of the petitioner as a recognised institution for the year 2021-22 on its website. The NCTE is also directed to communicate the same to the petitioner's affiliating university, and the concerned State Government within one week from today.
The Appellate Committee of the NCTE may also endeavour to dispose of the petitioner's appeal as expeditiously as expeditiously as possible and practicable, and will in any event do so not later than three months from today."
12. **NOW THEREFORE, recognition of the institution viz SHRI DHANESHWARI MANAV VIKAS MANDAL, COLLEGE OF EDUCATION, HATTA, TQ.BASMAT, HINGOLI, MAHARASHTRA for B.Ed. course with an annual intake of 100 students (Two units) is hereby restored.**
13. The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. 31.05.2015.
