Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. And whereas, the institution Center of Education, Indian Institute of Teacher Education (IITE) Swami Ramkrishna Paramhans Vidyadham, Sector- 15, District: Gandhinagar ,Gujarat- 382016. has by affidavit consented to come under New Regulations and sought recognition for two basic units (50 students each unit) in B.A. B.Ed.(Integrated Course) 4 years. Programme which require additional facilities.
- 3. And whereas, it has been decided to grant recognition to the institution to have two basic units of 50 students subject to the institution fulfilling following conditions namely,
  - (i). The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - (ii). The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
  - (iii). The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

  - The affidavit with enclosure submitted along with application.
  - j) The institution shall be free to post additional relevant information, if it so desires.
  - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
