REVISED ORDER

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993, and in supersession of the National council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. The Recognition was granted to the institution namely, **TRANSWAD B.ED COLLEGE MANAGED BY GEETA TRUST, VILLAGE-TARANASWAD, TA.VADNAGAR, POST OFFICE-BHALAK MESHANA-384319, GUJARAT**, for **M.Ed**. Course vide order No. WRC/5-6/325152/121st/2009/57525 dt. **13.07.2009** with an annual intake of 25 students.
- 3. And whereas, order dt. 24.01.2022 passed by Hon'ble High Court of Delhi at New Delhi in W.P. (C) No. 1327/2022 & CM APPLs.3991-93/2022 was placed in 363^{rd} meeting of the WRC held on 19^{th} to 20^{th} May, 2022 and the Committee decided as follows:-
 - "...The Original file of the Institution along-with other related documents was carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The committee decided to issue a Revised Recognition order to the institution for the M.Ed. programme with an intake of 50 students.

The institution is directed to submit the compliance of the said Revised Recognition order in accordance with Regulations 2014, within a period of 30 days."

- 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western, Regional Committee (NCTE) hereby issues the revised recognition order to TRANSWAD B.ED COLLEGE MANAGED BY GEETA TRUST, VILLAGE-TARANASWAD, TA.VADNAGAR, POST OFFICE-BHALAK MESHANA-384319, GUJARAT, for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit).
- 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
