WHEREAS, recognition was granted to the institution, namely, SHRI RAMNATH SINGH SHIKSHA MAHAVIDHALAYA, SITHOLI, JHANSI ROAD, GWALIOR 475001 MADHYA PRADESH vide order No. WRC/5-6/APW01572/223255/74/2004/C-203-209 dated 14.06.2006 for B.ED. (CO-ED) Course with an annual intake of 100 students.

AND WHEREAS, One Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 03.09.2014.

AND WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs. to the institution on 15-04-2015 and the institution was submitted reply on 01-10-2015 in WRC forwarded to Hqrs for necessary action.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 22-01-2015.

AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 28.05.2015.

AND WHEREAS, the VTR along with file of the institution were received from NCTE Hqrs. in WRO on 18.10.2016.

AND, WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255<sup>th</sup> meeting held on 22-24 June, 2016 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND, WHEREAS, Show Cause Notice of compliance was issued to the institution on 18.04.2017, and the reply was received on 15.05.2017.

AND WHEREAS, the matter was placed in 284<sup>th</sup> meeting of WRC held on November 28-29, 2017 and the Committee decided that "... In response to the Show Cause Notice dated 18.04.2017, the institution has not submitted the required staff profile in the NCTE format duly approved by the Registrar, Building Completion Certificate in the format and counter signed by a Govt. Engineer in original and the required FDRs for 12.00 lakhs.

Hence, Recognition is withdrawn from the academic session 2018-2019. FDRs, if any, be returned."

Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
