RESTORATION ORDER

WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely SHRI RAMNATH SINGH SHIKSHA MAHAVIDHALAYA, SITHOLI, JHANSI ROAD, GWALIOR – 475001, MADHYA PRADESH for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2005-2006 vide order no. WRC/5-6/APW01572/223255/74/2004/C-203-209 dated 14.06.2006.

- 2. AND WHEREAS, as per decision of WRC in its 115th Meeting held on 21 to 23 March, 2009 Refusal order issued to the institution for B.Ed. course vide order No. WRC/MP/Legal/APW01572 /223255/115th/2009/53221-53226 dated 02.04.2009.
- 3. AND WHEREAS, the institution filed an appeal to NCTE Hqrs. on 18.08.2009 against refusal order dated 02.04.2009 and the appeal committee passed an order dated 18.08.2009 with direction to WRC to restore the recognition of the institution immediately.
- 4. AND WHEREAS, the recognition was restored vide order no. WRC/5-6/Appeal/Apw01572/223255/2010/67168-67173 dated 06.04.2010 for conducting B.Ed. course for one year duration with an annual intake of 100 seats.
- 5. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution viz. SHRI RAMNATH SINGH SHIKSHA MAHAVIDHALAYA, SITHOLI, JHANSI ROAD, GWALIOR 475001, MADHYA PRADESH for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016 vide order No. WRC/APW01572/223255/74/2015 /137850-64 dated 28.05.2015.
- 5. **AND WHEREAS**, as per decision of WRC in its 284th Meeting held on 28th to 29th 2017 the recognition was withdrawn to the institution for B.Ed. course vide order No. WRC/APW01572/223255/284th/2017/193563-3565 dated 04.12.2017 on the following grounds:-

The case file was seen. In response to the Show Cause Notice dated 18.04.2017, the institution has not submitted the required staff profile in the NCTE format duly approved by the Registrar, Building Completion Certificate in the format and counter signed by a Govt. Engineer in original and the required FDRs for 12.00 lakhs.

6. **AND WHEREAS**, the institution filed an Appeal to the NCTE Hqrs. on 03.06.2019 against withdrawal order dated 04.12.20017 and the appeal committee passed an order dated 03.06.2019 and confirms the order appleade against. The institution has filed WP-234-2020, in the Hon'ble Hight Court of Madhya Pradesh against withdrawal order dated 04.12.2017. The Hon'ble High Court of Madhya Pradesh passed order dated 10.09.2020. The matter was considered by WRC in its 341st meeting held on May 17th to 18th August, 2021 and Committee decided to issue Show Cause Notice to the institution. Accordingly, Show Cause Notice u/s 17 was issued to the institution on 06.09.2021. The institution has not submitted reply of Show Cause Notice dated 06.09.2021.

- 7. **AND WHEREAS**, the institution filed Writ Petition No. 12963 of 2024, in the Hon'ble Hight Court of Madhya Pradesh at Gwalior. The matter was placed before the WRC in its 404th meeting held on 21st and 22nd May, 2024 and the WRC decided as under: -
 - "The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:
 - 1. Vide Order dated 10.09.2020 in W.P. No.234 of 2020 passed by Hon'ble High Court of Madhya Pradesh, the withdrawal order dated 04.12.2017 and appeal order dated 03.06.2019 were quashed and set aside along with the directions to consider the case of the institution.
 - 2. In the same W.P. No.234 of 2020, another order 14.12.2021 was passed by the Hon'ble High Court of Madhya Pradesh, wherein the order dated 10.09.2020 was confirmed.
 - 3. In pursuance of the same, a show cause notice was issued dated 06.09.2021 enclosing previous show cause notice dated 18.04.2017, which was issued for compliance of conditions of the revised recognition order dated 28.5.2015.
 - 4. Reply of show cause notice dated 06.09.2021 was not received from the institution.
 - 5. The institution again approached the Hon'ble High Court of Madhya Pradesh in W.P.No.12963 of 2024 and passed an order dated 16.05.2024.

In view of the above, the Committee decides the following:

- 1. Restoration order be issued in pursuance of Court order dated 10.09.2020 and 14.12.2021 subject to final decision or until a fresh withdrawal order is issued by WRC, NCTE.
- 2. In compliance of the Court Order, the status of recognition shall be updated on the NCTE Website.
- 8. NOW THEREFORE, this order is issued permitting the institution i.e. SHRI RAMNATH SINGH SHIKSHA MAHAVIDHALAYA, SITHOLI, JHANSI ROAD, GWALIOR 475001, MADHYA PRADESH restore the recognition for B.Ed. course for two-years duration with an annual intake of 100 (two basic units of 50 students each) subject to final decision or until a fresh withdrawal order is issued by WRC, NCTE.
