**WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely **VICTORIA COLLEGE OF PHYSICAL EDUCATION, 72/10,MADHUBAN FARM HOUSE NAYAPURA, KOLAR ROAD, BHOPAL, MADHYA PRADESH** vide Order No.WRC/5-6/91/2006/ dated 10.11.2006 for B.P.Ed. course of one year duration with an annual intake of 50 students.

AND, WHEREAS, the revised recognition Order was issued to the institution namely VICTORIA COLLEGE OF PHYSICAL EDUCATION, 72/10,MADHUBAN FARM HOUSE NAYAPURA, KOLAR ROAD, BHOPAL, MADHYA PRADESH vide order No. WRC/APW03403/224116/Revised order{M.P.}/2015/135249, 252, 255, 258, 259, 260, 262, 263 dt. 16.05.2015 for B.P.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-16 with certain conditions.

AND WHEREAS, the institution has not complied with the conditions of revised recognition order. The matter was considered by WRC in its 255<sup>th</sup> meeting and Committee decided to issued Show Cause Notice u/s 17 of NCTE Act 1993.

AND WHEREAS as per decision of WRC Show Cause Notice was issued to the institution on 08.02.2017.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice dt 08.02.2017. The matter was considered by WRC in its 303<sup>rd</sup> meeting held on 26<sup>th</sup>-28<sup>th</sup> February, 2019 and the Committee decided to withdraw the recognition for B.P.Ed. programme from the academic session 2019-2020. under Section 17(1) of the NCTE Act, 1993 on the following grounds:-

- The Show Cause Notice was issued to the institution vide letter dated 08/02/2017 & 03/04/2017.
- The institution has submitted reply of Show Cause Notice on 02/05/2017.

On perusal of the reply the institution has not submitted following documents:

- The institution has not submitted letter granting approval for the appointment of faculty by Affiliating University.
- The institution has not submitted Land use Certificate issued by Competent Authority.
- The land requirement for applied course is not as per NCTE norms.
- The institution has not submitted NEC issued by Competent authority.
- The institution has not submitted building plan approved by the competent authority.
- The institution has not submitted Building Completion Certificate issued by competent authority.

Regarding application of shifting of premises clarification was sought vide letter dated 17/11/2017 as per decision of 283<sup>rd</sup> meeting of WRC. The reply of same has not been received till date. Hence, the acceptance of application of shifting is not admissible.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee hereby withdraws recognition of **VICTORIA COLLEGE OF PHYSICAL EDUCATION, 72/10, MADHUBAN FARM HOUSE NAYAPURA, KOLAR ROAD, BHOPAL, MADHYA PRADESH** granted for **B.P.Ed** course on the grounds mentioned above from the academic session 2019-2020.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.


