WHEREAS, recognition was granted to the institution namely, BHARTI VIDYAPEETH'S DEEMED UNIVERSITY, COLLEGE OF PHYSICAL EDUCATION, KATRAJ, DHANKAWADI, PUNE, MAHARASHTRA (WRC/OAPW0157/114043) under section 14 of NCTE Act. 1993 for conducting B.P.ED. course vide order dated 18.07.2000 for an annual intake of 60 students.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institutions and the reply was received on 06.02.2015.

AND, WHEREAS, Revised Recognition order was issued for basic unit of 100 (one hundred) students with two sections of 50 (fifty) each to the institution on 31.05.2015.

AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.P.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 22.08.2016 and reply submitted by the institution on 06.09.2016 & 30.09.2016.

AND WHEREAS, the reply was placed in 292nd Meeting held on May 15-17, 2018 of WRC and the Committee decided that "... Consequent to the issue of Revised Recognition order, Show Cause Notice dated 22.08.2016 was issued for non-compliance.

The institution vide reply dated 02.09.2016 & 26.09.2016 has submitted the staff profile of 1 Principal, 1 Professor, 4 Associate Professors& 9 Assistant Professors as well as other subsidiary staff. The institution should submit the staff profile in original.

The institution should also submit FDR for additional Rs.4.00 lakhs in joint account in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND WHEREAS, the Clarification/Compliance letter issued on 02.06.2018 and reply submitted by the institution on 29.06.2018.

AND WHEREAS, the reply was placed in 297nd Meeting held on September 13-14, 2018 of WRC and the Committee decided that "... Consequent to the issue of Revised Recognition order, Show Cause Notice dated 22.08.2016 followed by a compliance letter dated 02.06.2018 were issued.

The institution replied on 29.06.2018. Since all the documents are in order, the institution is permitted to continue for one unit of 100 seats."
