ORDER

WHEREAS, the institution namely, Gayatri College of Education, Rahuri Rural Womens Institute of Educations A/P Deolali Pravara, Tal. Rahuri, Ahmednagar, Maharashtra-413716 was granted recognition by WRC NCTE for B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2005-2006 vide order No.WRC/2-32/123242/76/2005/6329 dated 09.08.2005.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/OAPW01784/1232422/2015/146277,280,283,284,286,289,290,292 dated 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic unit of 50 students each) from the academic session 2015-16.

3. AND WHEREAS, the institution has submitted a letter dated 03.02.2022 starting that it has opted for running one basic unit of 50 students in the first year for B.Ed. course in light of NCTE Regulations, 2014.

4. AND WHEREAS, the institution had Hon'ble the Hon'ble High Court of Bombay at Aurangabad vide W.P.(C) No.2182/2022, challenging the fees fixed by the Shikshan Shulk Samiti and the Hon'ble Court had passed an order dated 15.02.2022 which is as follows:-

- The petitioner is challenging the fees fixed by the Shikshan Shulk Samiti.
- Learned counsel for the petitioner submits that the Shikshan Shulk Samiti has reduced the fees for the current year. The said Samiti has wrongly considered the intake capacity of 100 instead of 50.
- Issue notice to the respondents, returnable on 22.02.2022. Learned AGP waives notice for respondent no.1.
- In addition to regular mode of service, the petitioner is permitted to serve respondent no.2 by E-mail also.
- Hamdust allowed.

5. AND WHEREAS, the matter was considered by the WRC in its 366th meeting held on 12th and 14th July, 2022 and the Committee decided as under:-

“Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

The institution has requested to reduce the intake from 100 to 50.

The committee has decided to reduce the intake of the B.Ed. course from 100 to 50 and a letter be issued to the institution accordingly.”



Rahuri, Ahmednagar, Maharashtra-413716** reducing the annual intake of B.Ed. course from 100 students (two units of 50 students each) to 50 students (one unit of 50 students) in light of NCTE Regulations, 2014.

The terms and conditions shall remain same as mentioned in the revised recognition order issued dated 31.05.2015.


