RESTORATION ORDER

WHEREAS, the institution, namely, BHABHA COLLEGE OF EDUCATION, NH-12, VILLAGE-JATKHEDI, HOSHANGABAD ROAD, DISTRICT-BHOPAL, MADHYA PRADESH was granted recognition by WRC NCTE for M.Ed. Course of with an annual intake of 25 (PG) vide Order No. WRC/5-6/102/2008/29870 dated 01.03.2008.

- 2. AND WHEREAS, Order of Increase in Intake issued to the institution from 25 to 35 vide order No. WRC/APW05453/225078/140TH/2010/73656-73662 order dated 12.01.2011 from the academic session 2010-2011.
- 3. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the Revised Order was issued to the institution vide No.WRC/APW05453/225078/{M.P}/2015/135334 dated 16.05.2015 for conducting M.Ed. Course with an annual intake of 50 students (one unit) from the academic session 2015-2016.
- 4. AND WHEREAS, the matter regarding compliance by the institution of the conditions of the Revised Recognition Order was placed in 255th meeting of WRC held on 22nd to 24th June, 2016 and the committee decided to issue Show Cause Notice to the institution. Accordingly, Show Cause Notice was issued to the institution on 13.01.2017.
- 5. AND WHEREAS, reply of Show Cause Notice vide letter dated 17.02.2017 was considered by WRC in its 297th meeting held on 13th-14th September, 2018 and committee decided that recognition be withdraw the institution. Accordingly Withdrawal Order was issued to the institution on 24.09.2018
- AND WHEREAS, being aggrieved the institution filed an appeal to NCTE against Withdrawal Order and NCTE Appellate Authority remanded back the case to WRC vide order dated 18.02.2019.
- 7. AND WHEREAS, matter was again placed in 309th meeting of WRC held on 23rd-26th July, 2019 and Committee decided that Show Cause Notice issue to the institution. Accordingly, Show Cause Notice issued to the institution on 08.08.2019.
- AND WHEREAS, reply of Show Cause Notice 20.08.2019 was considered by WRC in its 394th meeting held on 15th September, 2023 and Committee decided as under:

The original file of the institution along with other related documents was carefully time to time and the Committee observed as under:

The matter was considered by WRC and decides that the order for restoration of recognition for M.Ed. Course for one unit (50 Seats) be issued. The same shall also be uploaded on the NCTE website.

WRC further decides that show cause notice be issued to the institution under section 17 of NCTE Act, 1993 to submit the latest faculty list of M.Ed. Course with the approval letter of the affiliating body and copy of their qualification certificates within 15 days from the date of issue of Show Cause Notice.

8. NOW THEREFORE, in compliance of decision of WRC in its 394th meeting, recognition of Bhabha College of Education, Nh-12, Village-Jatkhedi, Hoshangabad Road, Bhopal, Madhya Pradesh for M.Ed. Course with an annual intake of one unit (50 seats) is hereby restored.

The terms and conditions shall remain the same mentioned in the revised recognition order issued vide order date 16.05.2015.
