Revised Recognition Order

Writ Petition (C) 8439 of 2017 titled SADBHAWNA CHARITABLE TRUST & ANR Versus SAURASHTRA UNIVERSITY & ORS and vide Judgment dated 09.02.2023.

WHEREAS, in exercise of the powers conferred by sub-Section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), add in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- And WHEREAS, In terms of Section 14(1)/Section 15(1) of the NCTE Act, 1993, Smt. 2. R.D.Gardi College, Run By Matrubhoomi Charitable Trust, At-Haripar (Pal), Opp. Motel, The Village Road, Kalawad Road, Rajkot -360005, Gujarat has submitted an application to the Western Regional Committee of NCTE for grant of recognition /permission for conducting M.Ed. (CO-ED) Programme with an annual intake of 25 students on 22.01.2007. WRC, NCTE has granted recognition to the institution for conducting M.Ed. (Co-Ed.) Programme with an annual intake of 25 under Section 15 of the NCTE Act, 1993 vide Order No.WRC/5-6/102nd /2008/30418-30423 dtd. 13.03.2008 from the academic session 2008-2009 and subsequently WRC's Order students vide 35 enhanced intake upto WRC/APW05558/325084/140/2010/71412-71416 dtd. 21.10.2010 from the academic session 2010-2011.
- 3. AND WHEREAS, Smt. R.D.Gardi College, Run By Matrubhoomi Charitable Trust, At-Haripar (Pal), Opp. Motel, The Village Road, Kalawad Road, Rajkot -360005, Gujarat by affidavit dated 06.01.2015 has consented to come under New Regulations and sought for 02 Basic Unit in M.Ed. (Co-Ed.) Programme which required additional facilities as per provisions laid down in aforesaid NCTE's Regulation 2014.
- 4. **AND WHEREAS,** on promulgation of NCTE Regulations, 2014, a Revised Recognition Order was not issued.
- 5. **AND WHEREAS**, the institution had filed a Writ Petition (C) 8439 of 2017 titled SADBHAWNA CHARITABLE TRUST & ANR Versus SAURASHTRA UNIVERSITY & ORS before the Hon'ble High court of Gujarat at Ahmedabad and vide Judgment dated 09.02.2023, Hon'ble High Court had directed the Respondent No. 3, NCTE the following:

G-7, Dwarka Sector 10, New Delhi-10075 Website: www.ncte.gov.in "In view of the above undisputed fact, the respondent No.2 could not have issued the impugned letter/order dated 10.04.2017. The respondent No. 3 – NCTE is also required to issue a revised order of recognition to the College run by the petitioner—Trust by continuing the college in the petitioner—Trust by continuing the college in the approved college list of the University and the respondent No.2 is required to continue the College of the petitioner—Trust in the approved colleges list of University for allotment of students of M.Ed.

In view of the foregoing reasons, the petition deserves to be allowed and is accordingly, allowed. The impugned letter dated 10.04.2017 is hereby quashed and set aside. The respondent No.2-University is directed to continue the College run by the petitioner-Trust in the list of the approved colleges of the University for the allotment of the students for M.Ed. course and the respondent No.3 is directed to issue the revised order of recognition of fulfilling the conditions by the College run by the petitioner-Trust within a period of twelve weeks from the date of receipt of the copy of this order in accordance with the Regulations considering the facts complied with all the requirements in the year 2015. Rule is made absolute to the aforesaid extent. No orders as to cost."

6. **AND WHEREAS,** the matter was placed in the 406th Meeting of WRC held on 24th – 26th July, 2024. The Committee decided the following:

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

In compliance of Order passed by the Hon'ble High Court of Gujarat dated 09.02.2023 in Special Civil Application No.8439/2017, Revised Recognition Order for one basic unit of 50 for M.Ed. Programme be issued as per NCTE Regulations, 2014 to the institution.

- 7. AND WHEREAS, it has been decided to permit the institution to have 50 Students (One Basic Unit) to M.Ed. (Co-Ed.) Programme subject to the institution fulfilling following conditions namely,
- The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available

on the website to the Regional Committee in proof of having provided additional facilities, Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.

- III. In case any existing institution's matter is sub-judice under court direction/SCN under Section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/Complaint/already submitted alongwith the documents, if any, together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulation, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/Case decided by the Western Regional Committee in respect of Section 17/Complaint cases etc.
 - 8. NOW THEREFORE, in the light of the above and in accordance with the NCTE Regulations 2014, the Western Regional Committee (NCTE) hereby issues the Revised Recognition Order to SMT. R.D. Gardi. College Sadbhavna Charitable Trust, At Haripar (Pal), Motel, The Village Road, Kalawad Road, Rajkot 360005, Gujarat for condition M.Ed. (Co-Ed.) Programme of two years duration with an annual intake of 50 students (One Basic Unit of 50 students) subject to fulfillment of the conditions mentioned above as well Show Cause Notice be issued separately.
 - 9. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisons of the NCTE Regulation, 2014 by the concerned institution before grant of affiliation to an institution.
 - 10. The institution shall submit to the Regional Committee a self-Appraisal Report at the end of each academic session along with the statement of annual accounts duly audited by a Chartered Accountant.
 - 11. The institution shall maintain & update its Web-site as per provision of NCTE Regulations, and always display following as mandatory disclosure:-
 - a. Sanctioned programme(s) along with annual intake in the institution;
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
 - c. Name of faculty members who left of joined during the last, quarter;
 - d. Name of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Free charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;

- h. Numbers of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with applicant;
- j. The institution shall be free to post additional relevant information if it so desires;
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition;

If the institution contravenes any of the above conditions of the provision of the NCTE Act, Rules, Regulations and orders made and issued under there, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
