- 2 AND WHEREAS, Order of Increase in Intake issued to the institution from 25 to 35 vide order. No. WRC/APW05453/225078/140TH/2010/73656-73662 order dated 12.01.2011 from the academic session 2010-2011.
- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the Revised Order was issued to the institution vide No.WRC/APW05453/225078/{M.P}/2015/135334 dated 16.05.2015 for conducting M.Ed. Course with an annual intake of 50 students (one unit) from the academic session 2015-2016.
- AND WHEREAS, as per decision of WRC taken in its 297th meeting said recognition was withdrawn of the institution and withdrawal order was issued to the institution vide order dated-24 09, 2018.

AND WHEREAS, Institution had filed an appeal before the council (MCTE) under section 18 of NCTE Act, 1993. The Appellate Authority vide its order dated 18.02.2019 remanded back the case to the WRC, NCTE. The institution submitted the reply/documents in response to Appellate Authority order.

- AND WHEREAS, as per decision of WRC taken in its 394th meeting said recognition has been restored and restoration order was issued to the institution on dated 19.09.2023.
- AND WHEREAS, the above society has created University namely Bhabha University, Bhopal by the Act, passed by the Govt. of Madhya Pradesh and requested to convert the above institution as Department of Education. Bhabha University, Bhopal for its M.Ed. course.
- AND WHEREAS, the case of the above institution was considered by the Western Regional Committee (WRC), NCTE in its 399th meeting held on 09th to 10th January, 2024 and WRC decided that "on creation of Bhabha University by the Govt, of Madhya Pradesh, under Ayushmati Education and Social Society, the Bhabha College of Education, run by the Ayushmati Education and Social Society, Nil-12 Village Jatkheri, Hoshangabad, Bhopal is hereby converted as Department of Education, Bhabha, Bhopal for its M.Ed. Course, Orders to change the name of the institution and affiliating body be issued accordingly."
