RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely, LIBERAL COLLEGE OF EDUCATION, SURVEY NO- 11/3/2, 13/2, 11/1/1, 11/2/1, VILLAGE - PIGDAMBER RAU, STREET/ROAD-IIM ROAD, TALUKA/MANDAL- MHOW, TOWN/CITY- PIGDAMBER RAU, DISTRICT- INDORE, PIN CODE-453331, MADHYA PRADESH under section 15(3)(a) of NCTE Act, 1993 for conducting D.EL.ED. course for 50 students thereby totalling to 50+50= 100 students from the academic session 2017-2018 vide order No. WRC/NCTE/APP201660177(ADDL.)/9829/222/275th/D.El.Ed./{M.P}/2017/185556-563 dt. 05.05.2017.

AND WHEREAS, the matter was placed in 291st Meeting of WRC held on 26-27 April, 2018 and the Committee decided that:- "...Compliance letter was issued to the institution on 03.01.2018 and reply received on 05.02.2018. The institution has not submitted a staff profile approved by the Registrar.

Secondly, the institution has submitted a Building Completion Certificate which is not signed by a Government Engineer.

Hence, Recognition is withdrawn from the end of the next academic session.

Simultaneously, Show Cause Notice be issued to the institution for two units of D.Ed. course (222414 & APP201660177) as to why the recognition should not be withdrawn since now the college has become standalone institution, which is not permitted."

AND WHEREAS, Accordingly, Show Cause Notice was issued to the institution on 14.05.2018 and reply of Show Cause Notice was not submitted by the institution.

AND WHEREAS, the matter was placed in 309th Meeting of WRC held on 23-26 July, 2019 and the Committee decided that:- "The Show Cause Notice was issued to the institution vide letter dated 14/05/2018. The reply of the Show Cause Notice of the institution has not been received.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for D.El.Ed. additional intake with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, Accordingly, Withdrawal order was issued to the institution on 30.07.2019

AND WHEREAS, the institution has filed an appeal NCTE, Hqrs. on 30.09.2019. The Appellate Authority vide its order dated 17.02.2020 remanded back the case to the WRC, NCTE, for necessary action.

AND WHEREAS, the matter was placed in 316th Meeting of WRC held on 27-28 August & 03 September, 2020 and the Committee decided that:-"The WRC examined the documents submitted by the institution in response to the order of the Appellate Authority and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for D.El.Ed course with an annual intake of 100 students (Two Units) be restored from the date of issue of order."
