RESTORATION ORDER

WHEREAS, the recognition was granted to the institution, namely, Laxmi Shikshan Sanstha And Krida Mandal, C/O Late Nirdhanrao Patil Waghaye D.Ed. College, Sadak Arjune, Gondia Road, Ta.Sadak Arjuni, Dist-Gondia, Maharashtra course of one year duration with an annual intake of 100 students vide order no. WRC/5-6/102(II Sitting)/2008/31749-31754 dated 28.03.2008.

2. AND WHEREAS, the matter was placed in the 107th WRC meeting held on September 6-7, 2008 and the Committee decided to permit the change of name of the institution as **Tirupati** Adhyapak Mahavidyalaya. Accordingly, letter dated 19.09.2008 was issued to the institution.

3. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order F.No.WRC/APW05306/123652/2015/150687-694 dated **12.08.2015** for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

4. **AND WHEREAS**, the matter was considered by WRC in its 375th meeting held on 18-19 November, 2023 and the Committee decided that the recognition of B.Ed. programme of institution be withdrawn under clause 17(1) of the NCTE Act, 1993, with effect from the end of the academic session next following the date of communication of the said order. Accordingly, Withdrawn Order was issued dated 09.12.2022.

5. AND WHEREAS, institution filed an appeal under Section 18(1) NCTE Act, 1993 before the Appellate Authority at NCTE, New Delhi against the aforesaid withdrawal order.

6. AND WHEREAS, in light of order dated 08/04/2021passed in the W.P. (c) No. 4382/2021 and dated 30.07.2021 passed in W.P. (c) No. 7260/2021 by the Hon'ble High Court of Delhi the withdrawal Order dated 09.12.2022 passed by WRC was set-aside by the Appellate Authority vide its order dated 12.09.2023 and remand back to WRC.

7. AND WHEREAS, WRC in its 385th meeting held on 17th may, 2023 has taken the following decision, "the committee unanimously resolved that all such matters where the case is remanded back by the appellate authority or through the orders of the court, the Regional Director is authorized to issue restoration order pending re-consideration of the withdrawal order.
