RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **MATUSHRI AHILYA DEVI TEACHERS EDUCATION INSTITUTE, VILL- SULAKHEDI (MANGLIA) POST- KADWALI, BUJURG, DIST-INDORE, MADHYA PRADESH** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/5-6/APPEAL/APW00638/223180/132/2010/67218-67223 dated 19-04-2010.

AND WHEREAS, Revised Recognition order was issued to **MATUSHRI AHILYA DEVI TEACHERS EDUCATION INSTITUTE, VILL- SULAKHEDI (MANGLIA) POST- KADWALI, BUJURG, DIST-INDORE, MADHYA PRADESH** vide order No. F.No. WRC/APW00638/223180/2015/ 148570 - 148578 dated 31-05-2015 for **B.ED** of Two Years Duration with an annual intake of 100 students for two basic unit of from the academic session 2005-2006.

AND WHEREAS, Compliance was not submitted as per regulations 2014.

AND WHEREAS, the matter was placed in **255th** Meeting of WRC held on June 22-24, 2016 and the Committee decided that "The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

AND WHEREAS, a Show Cause notice was issued to the institution on 10-08-2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

AND WHEREAS, the reply of show cause notice was submitted by the institution on 29.08.2016.

AND WHEREAS, the matter was placed in **284th** Meeting held on **November 28-29, 2017** of WRC and the Committee decided that:-

"...The case file was seen. In response to the Show Cause Notice dated 10.08.2016, the institution has submitted a list of sixteen faculty members. HOD has not been appointed. All the staff are qualified except faculty at S.No.13. The staff profile as per Appendix-IV of NCTE Regulations, 2014, approved by the affiliating body should be submitted in original.

Secondly, Building Completion Certificate signed by a Govt. Engineer and remaining FDR of Rs.4.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND WHEREAS, the clarification letter issued to the institution dated 01-12-2017 & the reply received in WRC 09.01.2019.

AND WHEREAS, the matter was placed in **310th** Meeting held on **August 19th-21st, 2019** of WRC and the Committee decided that:-

Due

"...The clarification letter was issued to the institution vide letter dated 1/12/2017. and reply received on 16/01/2019.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile for approved intake, Building Completion Certificate, CLU & Building plan are not submitted in original. Staff profile of 1+8 is insufficient to run two basic units. Additional FDRs Rs. 4 lakhs are not submitted.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.

AND WHEREAS, the Withdrawal order was issued to the institution on 28.08.2019.

AND WHEREAS, the institution filed an Appeal to the Council dt. 24.10.2019 and the Council vide its order dt 15.07.2020 remands back the case to the WRC, NCTE for necessary action and its reply received on 07.08.2020.

AND WHEREAS, the matter was placed in **321st** Meeting held on **November 09-11, 2020** of WRC and the Committee decided to issue Final Show Cause Notice to the institution. Accordingly Final Show Cause Notice was issued on 02.12.2020.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 7152/2021 dt. 28.07.2021. The operative parts is produced below:-

"...For the reasons aforesaid, it is directed that, for the academic year 2021-22 and subsequently, during the pendency of the remanded proceedings before the WRC until the passing of fresh withdrawal orders, if any, the institutions concerned will be entitled to participate in the counselling process and admit students. The NCTE is directed to restore the recognition of the petitioners by passing necessary orders to the effect t within one week. It will also update its website to reflect this position and communicate the restored status of the petitioners to their respective affiliating universities and the concerned State Governments within one week from today."

NOW THEREFORE, recognition of the institution viz to **MATUSHRI AHILYA DEVI TEACHERS EDUCATION INSTITUTE, VILL- SULAKHEDI (MANGLIA) POST- KADWALI, BUJURG, DIST- INDORE, MADHYA PRADESH** for **B.Ed. course with an annual intake of 100 students (Two units) is hereby restored.**

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. **31.05.2015.**
