ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to ACHARYA VIRAG SAGAR VIDHYAPEETH, RUN BY ACHARYA VIRAG SAGAR VIDYAPEETH SHIKSHA SAMITI, KHASRA NO. - 307/1, 307/4, PLOT NO. - 01, STREET NO. - 03, VILLAGE - KIRRAVADA BINA, P.O. + TEHSIL - BINA, DIST. – SAGAR - 470113, MADHYA PRADESH vide order dated 01.03.2014 to start the B.ED. (CO-ED) course with an annual intake of 100 students.

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 14.01.2015. The institution submitted affidavit vide letter dated 19.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (50 students each) to the institution on 13.05.2015.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... issue Show Cause Notices to the institution of the condition maintained in revised order."

AND, WHEREAS, the Show Cause Notice was issued to the institution on 28.02.2017 and the reply of Show Cause Notice was received on 06.04.2017.

AND WHEREAS, the matter was placed in 285th Meeting of WRC held on December 19th – 21st, 2017 and the Committee decided that "... In response to the Show Cause Notice dated 10.02.2017, the institution vide letter dated 16.03.2017 has submitted scanned copy of approved staff list of 1+7 faculty members, which is sufficient for only one unit. However, the staff profile in original approved by the Registrar is required to be submitted.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND, WHEREAS, letter seeking Clarification was issued to the institution on 03.01.2018 and the reply was received on 31.01.2018.

AND WHEREAS, the matter was placed in 291st Meeting of WRC held on April 26th – 27th, 2018 and the Committee decided that "... In compliance to letter dated 03.01.2018, the institution has submitted a staff profile of 1+11 faculty members approved by the Registrar. This is sufficient for one unit.

Hence, the institution is permitted to continue with reduced intake of one unit (50 students) in B.Ed. course."
