## RESTORATION ORDER

F.No.WRC/2-32/163/2004/5353 dated 24.08.2004.

- AND WHEREAS after promulgation of NCTE Regulations, 2014, the revised order institution vide the issued to was order recognition 31.05.2015 for WRC/APW00798/123132/2015/146453,461,463,465,466,468,469 dated conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, the matter was considered by WRC in its 287<sup>th</sup> meeting held on January 30-31, 2018 and the Committee decided that the recognition is withdrawn from the academic session 2018-2019. Accordingly, Withdrawal Order was issued dated 06.02.2018.
- 4. AND WHEREAS, institution filed an appeal under Section 18(1) NCTE Act, 1993 before the Appellate Authority at NCTE, New Delhi and the Appellate Authority passed an order dt. 24.07.2018 and remand back to WRC.
- 5. AND WHEREAS, WRC in its 385<sup>th</sup> meeting held on 17<sup>th</sup> may, 2023 has taken the following decision, "the committee unanimously resolved that all such matters where the case is remanded back by the appellate authority or through the orders of the court, the Regional Director is authorized to issue restoration order pending re-consideration of the withdrawal order subject to ratification by the Committee in the ensuing meting."
- 6. NOW THEREFORE, In terms of above decisions taken by WRC and Appellate Authority the said recognition granted to the above institution viz. Bhartiya Grmin Punarrachna Sansthas, Mumbai B.Ed. College For Women J.K. Knowledge Center, Nadkarni Park, Near MBPT Hospital, Wadala (East), Mumbai-400037, Maharashtra for conducting B.Ed. programme of two years duration with an annual intake of 100 students (Two units) is hereby restored subject to further consideration of WRC.
