## ORDER

- + 4. The institutions shall ensure the fulfillment of the following :-
  - (a) The institutions shall maintain the teaching staff strength of 1+7 for the proposed B.Ed. course.
  - (b) The institutions shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.
  - (c) The institutions shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
  - (d) The institutions shall within one month of the receipt of the Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.
