WHEREAS, the recognition was granted to the institution, namely, SHRI COLLEGE OF EDUCATION, RUN BY SMT. PUSHPA SHIKSHA PRASAR SAMITI, INFRONT OF COMMUNITY HALL, KANCH MILL, BIRLA NAGAR, GWALIOR – 474004, MADHYA PRADESH for NCTE Course vide order dated 04.08.2009 for an annual intake of 50 seats.

AND WHEREAS, the complaint received from Madhyamik Shiksha Mandal, Bhopal against the Colleges located in Gwalior was considered by the NCTE in its 229th meeting held on July 21-22, 2015 and it was decided that "the complaint be put up with recognition status of 39 institutions mentioned in the letter for consideration."

AND WHEREAS, the matter was again considered by the NCTE in its 231st meeting held on August 25-26, 2015 and it was decided that "...the institutions figuring in the list provided by the Madhyamik Shiksha Mandal be verified from the records whether the inspection of the institutions was carried out by the Collector, Gwalior earlier and after verification, detailed note be submitted for consideration."

AND WHEREAS, the Collector, Gwalior vide letters dated 23/11/2015 and 16/12/2016 forwarded the reports of inspection to the office of Lokaayukt, M.P. which were forwarded to Madhyamik Shiksha Mandal vide their letter dt. 15/03/2016. Madhyamik Shiksha Mandal forwarded the copy of reports to the NCTE for action against the institutions.

AND WHEREAS, the matter was placed before the NCTE in its 253rd meeting held on May 24-26, 2016 and the Committee decided that, "...As per report the staff was not found available at the time of inspection. Hence, Show Cause Notice under section 17 be issued to the institution on the ground that no activity was being conducted at the time of inspection. A CBSE School was being run for which no separate built up area is earmarked. Built up area is less even for the NCTE course. Neither students nor staff was available. Building was not found at the time of inspection. Further, the institution should submit the latest approved list of the staff." Accordingly, Show Cause Notice was issued on 13.06.2016.

AND WHEREAS, the reply received from the institution was placed before NCTE in its 260th meeting held on October 13-15, 2016 and the Committee decided that "...Show Cause Notice was issued to the institution on the ground that staff and students were not found available on the day of inspection. Further, a CBSE School is being run for which separate built up area is not earmarked. The building has only 1444 sq. mtrs. Of built up area which is not sufficient for the NCTE course. The institution has not replied to the Show Cause Notice adequately. Hence, Show Cause Notice be issued as to why the Recognition should not be withdrawn. Reply should be submitted to the NCTE within 15 days." Accordingly, Show Cause Notice was issued on 18.10.2016.

AND WHEREAS, the reply received from the institution was placed before NCTE in its 265th meeting held on December 27-29, 2016 and the Committee decided that "...Show Cause Notice was issued to the institution on the ground that staff and students were not found available on the day of inspection. Further, a CBSE school is being run for which area is not earmarked. The area is only 1444 sq. mtrs. The institution has not replied to the points of the Show Cause Notice regarding built up area. Hence, Recognition is withdrawn. Accordingly, Withdrawal order was issued on 09.01.2017.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Withdrawal order dated 09.01.2017 and the Council vide order dated 29.05.2017 remanded the case to NCTE to relook into the matter in the light of the submission of the appellant about their proposal for shifting and take a fresh decision as per the NCTE Regulation, 2014 till such time, the withdrawal order dated 09-01-2017 shall be kept in abeyance.

AND WHEREAS, the aforesaid appeal order was placed in the 277th WRC meeting held on June 29-30, 2017 and the Committee decided that "...This is a case of Appeal. The recognition was withdrawn after following due procedure. The Appeal Committee vide order 29/05/2017 has remanded the case to WRC to take a fresh decision in the light of the application of the institution for shifting in 2014. The claim of the institution to have applied for shifting in 2014 is not traceable in the file. The institution is required to submit notarized copies of application, the application fee and the other relevant documents required, which were submitted earlier, as claimed before the Appeal Committee. The order of withdrawal is kept in abeyance. Show Cause Notice be issued on the above grounds. Reply be submitted within 1 month." Accordingly, Show Cause notice was issued on 10.07.2017.

AND WHEREAS, the institution filed W.P. No.3448/2017 before the Hon'ble High Court of Madhya Pradesh, Bench at Gwalior and the Hon'ble High Court had passed an order dated 19.06.2017.

AND WHEREAS, the aforesaid court order was placed before WRC in its 278th WRC meeting held on July 25-26, 2017 and the Committee observed that "...In response to show cause notice letter dt. 10.07.2017, the institute was asked to submit notarized copy of application, application fee and other relevant documents which the institute claims it has submitted before the appeal committee regarding shifting of institution. The institute has not replied to the show cause notice. In the meanwhile the Hon'ble High Court of Madhya Pradesh at Gwalior has directed the WRC to decide the matter within a week. The institute is required to sent its compliance within one week." Accordingly, Letter was issued on 31.07.2017.


AND WHEREAS, the reply received from the institution was placed before WRC in its 281st meeting held on September 19-20, 2017 and the Committee decided that "...In its 278th meeting, the WRC had asked the institution to submit various documents, application fee etc. within one week to settle the case as directed by the Hon'ble High Court of Madhya Pradesh Bench at Gwalior. The institute vide letter dt. 09.08.2017 had requested for one month extension. Although one month has already elapsed, the institution is given time till 9th October, 2017 to submit same failing which recognition will be withdrawn." Accordingly, letter was issued on 03.10.2017.

AND WHEREAS, the institution had applied for shifting of premises on 13.02.2018 at SHRI COLLEGE OF EDUCATION, KHASRA NO.40, VILLAGE CHAKJUGRUPURA, MADANPURA SUSHERA ROAD, GWALIOR – 474005, MADHYA PRADESH.

AND WHEREAS, the matter was placed before the WRC in its 288th meeting held on February 15-16, 2018 and the Committee decided that, "...Consequent to the issue of Show Cause Notice dated 10.07.2017, the institution has submitted application together with the application fee. Since it has the required diverted land and building, VT be constituted."

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 02.03.2018.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 289th Meeting held on March 1 & 3, 2018 The Committee decided that "...This is a case of shifting. The VTR was perused and the CD was seen. The CD shows a good building with good infrastructural and instructional facilities. **Hence, Recognition is restored and the shifting is permitted.**"

NOW, THEREFORE, the Western Regional Committee hereby restores the recognition to SHRI COLLEGE OF EDUCATION, KHASRA NO.40, VILLAGE CHAKJUGRUPURA, MADANPURA SUSHERA ROAD, GWALIOR – 474005, MADHYA PRADESH for conducting D.Ed. Course with an annual intake of 50 seats with the same terms and conditions as mentioned in the recognition order dated 04.08.2009.
