AND WHEREAS, Restoration order was issued to NES college of Education, Behind S.N.G, School, Hoshangabad, Madhya Pradesh vide order No. WRC/APW03487/225016/M.ED./(M.P)313th/2020/208641 dated 23/6/2020. For conducting M.Ed course with an annual intake of one unit(50 students).

AND WHEREAS, letter regarding submission of application in the prescribed format issued to the institution on 04.08.2022

AND WHEREAS, the reply dated 30.11.2022 submitted by the institution, was received on 05.12.2022

AND WHEREAS, the proposal was examined and the deficiency letter was issued to the institution on 15.02.2023 on the following points:

- Application to be submitted in triplicate.
- Building Completion Certificate submitted does not indicate total area, built up area.
- There is no mention of shifting of premises in the affidavit.
- DD Rupees 1,50,000/- DD No. 623943 date 12/05/2022

AND WHEREAS, the reply dated 15.03.2023 submitted by the institution, was received on 27.03.2023

AND WHEREAS, the matter was placed before WRC in its 391st meeting held on 3th and 4th August, 2023. The Committee decided that VT be constituted. Accordingly, inspection was conducted on 16.08.2023.

AND WHEREAS, the matter was placed before WRC in its 397th meeting held on 21st November 2023. The Committee decided to issue Show Cause Notice to the institution on the following grounds:-

 Multipurpose hall is too small to accommodate M.Ed. Course students and psychology lab required more test and library should have more reference books.

AND WHEREAS, show cause Notice issued to the institution on 22.12.2023.

AND WHEREAS, the reply dated 19.01.2024 submitted by the institution, was received on 29.01.2024

WHEREAS, recognition was granted to the institution, namely, **NES COLLEGE OF EDUCATION**, **BEHIND S.N.G. SCHOOL, HOSHANGABAD – 461001, MADHYA PRADESH** under section 14(3)(a) of NCTE Act, 1993 for conducting M.ED. course for 40 students vide order No. WRC/5-6/88/2006 dated 15.09.2006.

- 2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 22.12.2014 and the reply was received on 19-03-2015.
- 3. AND WHEREAS, the revised recognition order was issued to **NES COLLEGE OF EDUCATION**, **BEHIND S.N.G. SCHOOL**, **HOSHANGABAD 461001**, **MADHYA PRADESH** vide order no. WRC/APW03487/225016/{M.P.}/2015/135004-5011 dt. 13.05.2015 for M.Ed. Programme of two years duration with an annual intake of 50 students (One unit) from the academic session 2015-16 with certain conditions.
- 4. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 5. AND WHEREAS, a Show Cause Notice was issued to the institution on 10.01.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
 - 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
 - 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.
- 6. AND WHEREAS, the reply of Show Cause Notice was submitted by the institution on 30.01.2017.
- 7. AND WHEREAS, the matter was placed in 292nd Meeting of WRC held on May 15th-17th, 2018 and the Committee decided that:- "....Consequent to the issue of Revised Recognition order, Show Cause Notice dated 10.01.2017 was issued. The institution vide reply dated 24.01.2017 has submitted a staff profile of 1 Professor, 3 Assistant Professors, which is not as per Appendix-V of NCTE Regulations, 2014. The institution has also not submitted the Building Completion Certificate signed by the Government Engineer.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

- 8. AND WHEREAS, the Clarification letter was issued to the institution on 24.05.2018.
- 9. AND WHEREAS, the institution has submitted reply vide letter dt. 21.06.2018 received in WRO on 02.07.2018.
- 10. AND WHEREAS, the matter was placed in 304th Meeting of WRC held on April 02nd-04th, 2019 and the Committee decided that:-"....The compliance letter was issued to the institution on24/05/2018. The institution has submitted reply dated 21/06/2018 received in the office of WRC on 02/07/2018.

On perusal of the reply of the institution it is observed that the institution has not submitted the

The institution has submitted list of five faculty (one Principal, One Professor, Three Assistant Professor) signed by Registrar, Baraktullah University, Bhopal but Date of Signature of Registrar of University not mentioned.

Only Six approval letter of Assistant Professor issued by Barakutullah University vide letter dated 27/10/2015 which was submitted by the institution.

As per NCTE Regulations 2014 for M.Ed. programme two professor, two Associate Professor and Six Assistant Professor is required.

The institution has not submitted a letter granting approval for the selection or appointment of faculty, issued by the affiliating body as per NCTE Regulations 2014.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for M.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- 11. AND WHEREAS, the Withdrawal order was issued to the institution on 12.04.2019.
- 12. AND WHEREAS, An E-mail received from the institution on 06.06.2019 with enclosed Court Order of Hon'ble High Court of Delhi at New Delhi, Date of Decision 28th May 2019 and the institution has filed an appeal NCTE, Hqrs. on 04.06.2019. The Appellate Authority vide its order dated 27.08.2019 remanded back the case to the WRC, NCTE, for necessary action. Accordingly, institution has submitted documents in WRO on 18.10.2019 received.
- 13. AND WHEREAS, the matter was placed in 313th Meeting held on February 25th-27th, 2020 of WRC and the Committee decided that:-

"The Committee considered the matter keeping in view the order of the Appellate Authority dated 27.08.2019 and decided that the recognition of the institution be restored with the existing annual intake of one unit (50 students)."

14. NOW THEREFORE, the recognition of, NES COLLEGE OF EDUCATION, BEHIND S.N.G. SCHOOL, HOSHANGABAD - 461001, MADHYA PRADESH be restored for conducting M.Ed. course with an annual intake of 50 students (One unit).
