"Committee considered the V.T. report for shifting, original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The institution has complied with all the requirements as per NCTE Regulations and WRC decided to permit the shifting of premises to Sarvamangalam Education Trust, Sanskar B.Ed. College, At.
