

RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **B.ED WOMENS COLLEGE, SOMNATHARPAN SHIKSHAN PRASARAK SANSTHA, PLOT NO. 746/1 & PLOT NO. 9 & 10, KHASRA NO. 11443/314, SAVDA ROAD, RAVAR, DIST-JALGAON, MAHARASHTRA** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course, with an annual intake of 100 students (Two basic unit of 50 students each) vide order No. APW04479/123538(GIRLS ONLY)/WRC/5-6/110/2008/46719-21 dated 22.11.2008.

2. **AND WHEREAS**, Revised Recognition order was issued to **B.ED WOMENS COLLEGE, SOMNATHARPAN SHIKSHAN PRASARAK SANSTHA, PLOT NO. 746/1 & PLOT NO. 9 & 10, KHASRA NO. 11443/314, SAVDA ROAD, RAVAR, DIST-JALGAON, MAHARASHTRA** vide order No. F.No. WRC/APW04479/123538/2015/ 143060-65 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic unit of (50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, Compliance was not submitted as per regulations 2014.

4. **AND WHEREAS**, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. **AND WHEREAS**, a Show Cause notice was issued to the institution on 23.02.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

6. **AND WHEREAS**, the reply of show cause notice was submitted by the institution on 21.04.2017.

7. **AND WHEREAS**, vide Order dt. 30.01.2017 NCTE has reduced intake from Two(2) units(100 students) to one (1) unit (50 students) to conduct of B.Ed. course.

8. **AND WHEREAS**, the matter was placed in 316th Meeting held on August 27-28, & September 03rd 2020 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

9. **AND WHEREAS**, a Show Cause Notice was issued to the institution on 29-09-2020 as per decision of WRC, and its reply not received by the institution.

10. **AND WHEREAS**, the matter was placed in 322st Meeting held on November 23-24, 2020 of WRC and the Committee decided that.

"... The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. *Recognition was granted to the institution on 22.11.2008 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.*
2. *The institution has not shifted the institution in its own premises till date.*
3. *Accordingly, Show Cause Notice was issued to the institution on 29.09.2020.*
4. *The institution has not submitted the reply of the Show Cause Notice till date.*

In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be WITHDRAWN under section 17 (3) of the NCTE Act from the next academic session 2021-22."

11. **AND WHEREAS**, the Withdrawal order was issued to the institution on 11-12-2020.

12. **AND WHEREAS**, the institution has filed an appeal against the Withdrawal order dt. 11.12.2020 and the Council vide its order dt 26.03.2021 remands back the case to the WRC, NCTE for necessary action.

13. **AND WHEREAS**, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 14373/2021 dt. 15.12.2021 the operative part is produced here below:-

"...The petition is, therefore, allowed and the NCTE is directed to issue an order of restoration of recognition. The petitioner will be permitted to participate in counselling and admit students for the year 2021-22 and for subsequent years, until and unless a fresh withdrawal order is passed against it. The status of the petitioner as a recognised institution will also be reflected on the respondent-NCTE's website, and will be communicated by the NCTE to the petitioner's affiliating university as well as to the concerned departments of the State Government. The NCTE is directed to comply with these directions within one week."

14. **NOW THEREFORE**, recognition of the institution viz B.ED WOMENS COLLEGE, SOMNATHARPAN SHIKSHAN PRASARAK SANSTHA, , PLOT NO. 746/1 & PLOT NO. 9 & 10, KHASRA NO. 11443/314, SAVDA ROAD, RAVER, DIST-JALGAON, MAHARASHTRA for B.Ed. course with an annual intake of 50 students (one unit) is hereby restored.

15. The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. 31.05.2015.
