- **4. AND WHEREAS**, the institution has not submitted the compliance to the Revised recognition order and the matter was placed in its 255^{th} meeting held on 22^{nd} - 24^{th} June ,2016-276th meeting held on 30^{th} - 31^{st} May , 2017 and Committee decided as under:-
 - 1. A copy of staff profile, of qualified teaching staff appointment by institution, for session 2015-2016, 2016-2017, 2017-2018, duly approved by affiliating body.
 - 2. Building Completion certificate (BCC) as per Govt. Format issued by RES/Govt. Engineer is not submitted.
 - 3. FDRs of 5 Lakhs, as Endowment, and Rs. 7 lakh, as Reserve Fund per unit , in joint operation with Regional Director, WRC (NCTE) Bhopal as per NCTE Regulation , 2014 is not submitted .
 - 4. Original notarized CLU (certificate of Land Use), Non Encumbrance certificate, Approved Building Plan issued by engineer of Rural Engineering service or PWD Engineer.
- 5. AND WHEREAS, a Show Cause Notice no. <u>WRC/APW02609/ 323304/B.Ed./Guj./2017/ 193690-692</u> dt. <u>06.12.2017</u> was issued to the institution.
- 6. AND WHEREAS, the institution vide letter no 23/2017-18 dt. 23.02.2018 submitted by the institution and the matter was placed before the WRC in its 293rd Meeting held on June 12th -14th ,2018 and the Committee has decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 29.08.2016 was issued and the institute replied on 23.02.2018. The institute has submitted a photocopy of staff profile 1+14 (excluding Sr. No. 14 & 17). The institute needs to submit staff profile of (1+15) in original as per appendix IV of NCTE Regulations, 2014 and NCTE Notification No. 237, dated. 09.06.2017.

The institute also needs to maintain FDRs for 12 Lakhs as per NCTE Regulations, 2014.

- 7. AND WHEREAS, a conveying order no. WRC/APW02609/323304/B.Ed./293rd/Guj./2018/198665-668 dt. 22.06.2018 was issued to the institution.
- 8. AND WHEREAS, reply dt. 12.07.2018 & 11.06.2019 submitted by the institution and the matter was placed before the WRC in its 339th meeting held on 28th 30th July, 2021 considered the matter and committee decided as follows:-

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

Recognition of the institution be continued for the B.Ed programme with an intake of two unit of 50 students.

The WRC also decided that the institution be directed to submit the current staff list for the academic session 2021-2022 for consideration by WRC."

- 9. Now Therefore, the WRC decided to permit the institution i.e. BHAVNA B.ED. COLLEGE, SHANTASHIV EDUCATION TRUST, PLOT NO.-66, RAJPATNAGAR, OPP GOVT WELL, TAL-DASCROI BHOPAL, AHEMDABAD-GUJARAT for continuation of recognition for B.Ed. course subject to fulfilment of the following conditions:
 - a) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - b) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - c) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - d) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - e) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **10.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Western Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a) Sanctioned programme(s) along with annual intake in the institution.

- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left of joined during the last, quarter:
- d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e) Free charged from students.
- f) Available infrastructural facilities.
- g) Facilities added during the last quarter;
- h) Numbers of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **13.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its officials website.
- 14. The institution shall make available the list of students admitted on its officials website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.
- 16. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Western Regional Committee under the provisional of Section 17 of the NCTE Act, 1993.
