CONTINUE ORDER

WHEREAS, recognition was granted to the institution namely NIRMAL TEACHER'S TRAINING COLLEGE, B-32, MOHAN NAGAR, HINDAUN CITY, DISTRICT-KARAULI-322230, RAJASTHAN vide Order No. F.NRC/NCTE/F-3/RJ-959/22965-72 dt. 02.08.2007 for B.Ed. course of one year duration with an annual intake of 100 students.

AND WHEREAS, the matter was considered in 159^{th} NRC meeting held on 28^{th} April to 1^{st} May 2010 and the Committee observed that:

"...The original file of the institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee and the committee observes the following:

- Submitted CLU is not proper.
- Land is in the name of the Society but not Institution.
- Submitted Building map is not approved.
- The existing Faculty has not been selected through dully constituted selection committee as per NCTE norms.

Hence, the committee decided to withdraw recognition of B.Ed. course from 2010-2011 academic session."

AND WHEREAS, a withdrawal order was issued to the institution dated 14.05.2010.

AND WHEREAS, the institution had approached the Hon'ble High Court of Judicature for Rajasthan at Jaipur Bench Jaipur W.P. (C) No. 12478/2010 dt. 24.09.2010.

AND WHEREAS, the institution has filed an Appeal Appellate Authority has passed an order dt. 07.10.2010.

AND WHEREAS, the matter was considered in 174th NRC meeting held on December 08-10, 2010 and the Committee observed that:

"...The matter is sub-judice. The Hon'ble High Court of Rajasthan, Jaipur has stayed the NRC order dated 14.05.2010, withdrawing the recognition of the B.Ed. course vide its order dated 24.09.2010. Meanwhile, the applicant also moved to the Appellate Authority, NCTE, which also reversed the said orders of NRC and asked for issue of Show Cause Notice to the institution on the grounds of withdrawal. As such, NRC Advocate may be asked to take up the matter before the Hon'ble Court and the NRC could take further action, as per orders of the Appellate Authority."

AND WHEREAS, a show cause notice was issued to the institution dated 19.04.2011 and its reply received on 23.02.2012.

AND WHEREAS, the revised recognition order was issued to the institution namely Nirmal Teacher's Training college, B-32, Mohan Nagar, Hindaun City, District-Karauli-322230,

Rajasthan vide order no. F.No./NRC/NCTE/F-3/RJ-959/2015/98994-999 dt. 14.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students from the academic session 2015-16.

AND WHEREAS, the matter was considered in 243rd NRC meeting held on September 28-30, 2015 and the Committee observed that:

"...The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.

The committee considered the documents submitted by it and also seen the Order issued by the Hon'ble Court and observed that the deficiencies pointed out earlier have been rectified vide a reply submitted. Thereafter the institution has been issued a Revised Recognition Order and at present the institution stands recognized and it was being run under Court directions. The institution submitted a letter again requesting the NRC to consider the reply which it considered and decided that since the deficiencies pointed out earlier have been rectified the recognition be restored."

AND WHEREAS, a restoration order was issued to the institution dated 08.10.2015.

AND WHEREAS, the matter was placed in 316th WRC meeting held on October 13, 2018 and the Committee observed that:

"... The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation were made:

- 1. The institution is required to submit the latest staff list duly approved by the affiliating body.
- 2. The approval letter of the affiliating university along with proof with the present university required to be submitted by the institution.

In view of the above, the Committee decided that show Cause Notice prior to refusal of recognition be issued to the institution u/s 14/15 (3) (b) of the NCTE Act for B.Ed. programme."

Accordingly, show cause notice was issued to the institution on 14.10.2020 and its reply received on 11.11.2020, 11.10.2022 & 13.10.2022.

AND WHEREAS, the matter was considered in the 374th meeting (Part-1) of WRC held on 18th and 19th October, 2022 and the Committee has decided the following:-

"...The original file of the Institution along-with other related documents, representation dated 11.11.2020 in response to show cause notice dated 14.10.2020 issued after issuance of restoration order dated 08.10.2015, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided that the institution has fulfilled the criteria laid down under extant NCTE Regulations, 2014 (as amended time to time).

In view of the above, the Committee decided that recognition to B.Ed. course be continued. Hence, order of continuation of recognition to B.Ed. course of two

years duration be issued to the institution, affiliating body/State Government and all others concerned accordingly."

NOW THEREFORE, the recognition of Nirmal Teacher's Training College, bayana road, Hindaun City, District-Karauli, Rajasthan for conducting B.Ed. course is permitted to Continue with an annual intake of 100 students (Two basic units of 50 each).
