Sub: Compliance of 307th WRC meeting decision.

Sir,

The Recognition was granted to the institution namely **VICTORIA COLLEGE OF PHYSICAL EDUCATION, 72/10, MADHUBAN FARM HOUSE NAYAPURA, KOLAR ROAD, BHOPAL, MADHYA PRADESH** vide Order No.WRC/5-6/91/2006/ dated 10.11.2006 for **B.P.Ed.** programme with an annual intake of 50 students.

The revised recognition order was issued to the institution namely **VICTORIA COLLEGE OF PHYSICAL EDUCATION, 72/10, MADHUBAN FARM HOUSE NAYAPURA, KOLAR ROAD, BHOPAL, MADHYA PRADESH** vide order No. WRC/APW03403/224116/Revised order{M.P.}/2015/ 135249, 252, 255, 258, 259, 260, 262, 263 dt. 16.05.2015 for B.P.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-16.

As per decision of WRC in its 255th meeting. Show Cause Notice was issued to the institution vide letter dt. 08.02.2017 on the following grounds:-

- Staff Profile for the session 2015-16 duly approved by the Affiliating Body.
- Originally notarized CLU/NEC/BP and Building Completion Certificate.

The institution has not submitted reply of Show Cause Notice dt 08.02.2017. The matter was considered by WRC in its 303rd meeting held on 26th-28th February, 2019 and the Committee decided to withdraw the recognition for B.P.Ed. programme from the academic session 2019-2020. under Section 17(1) of the NCTE Act, 1993 on the following grounds:-

- The Show Cause Notice was issued to the institution vide letter dated 08/02/2017 & 03/04/2017.
- The institution has submitted reply of Show Cause Notice on 02/05/2017.

On perusal of the reply the institution has not submitted following documents:

- The institution has not submitted letter granting approval for the appointment of faculty by Affiliating University.
- The institution has not submitted Land use Certificate issued by Competent Authority.
- The land requirement for applied course is not as per NCTE norms.
- The institution has not submitted NEC issued by Competent authority.
- The institution has not submitted building plan approved by the competent authority.
- The institution has not submitted Building Completion Certificate issued by competent authority.

Regarding application of shifting of premises clarification was sought vide letter dated 17/11/2017 as per decision of 283rd meeting of WRC. The reply of same has not been received till date. Hence, the acceptance of application of shifting is not admissible.

Accordingly, withdrawal order was issued to the institution on 12.03.2019.

The Institution has filed W.P. 5282/2019 of CM APPLs. 23409-410/2019. In the High Court of Delhi at New Delhi against withdrawal order dt. 12.03.2019. The Hon'ble High Court of Delhi passed order dt. 15.05.2019.

The matter was considered by WRC in its 307th meeting held on May 30-31, 2019 and Committee decided as under:-

"In view of the direction of the Hon'ble High Court of Delhi in W.P.(C) 5282/2019 & CM APPLs 23409-410/2019 order dated 15/05/2019 at point No. 08, decision of WRC about the withdrawal order stayed and website be updated accordingly."
