Restoration Order

WHEREAS, recognition was granted to the institution namely SHETHKARI SHIKSHAN PRASARAK MANDAL, COLLEGE OF PHYSICAL EDUCATION, ASHTI, DISTRICT- BEED- 414203, MAHARASHTRA, under section 14 of NCTE Act, 1993 for conducting B.P.ED., course, vide order No. WRC/5-6/16/99/4453-4455 dated 26.07.1999.

2. AND WHEREAS, the letter of submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution submitted affidavit vide letter dated 06-01-2015.

3. **AND WHEREAS**, revised recognition order was issued for basic unit of 100 (one hundred) students and with two sections of 50 (fifty) each of the institution on 31.05.2015.

4. AND WHEREAS, the matter was placed in 255th meeting of WRC held on June 22-24, 2016 and the committee decided that '... Issue Show Cause Notice to the institution for the condition mentioned in revised order."

5. **AND WHEREAS**, a Show Cause Notice of compliance was issued to the institution on 27.10.2016, and the reply of the Show Cause Notice was not submitted by the institution.

6. **AND WHEREAS**, the matter was placed before the WRC in its 280th meeting held on August 31 and September 01, 2017, and the committee decided that "... Show Cause Notice was issued to the institution on 27.10.2016. The institute has not replied till date. *Hence, Recognition is withdrawn from the session 2018-2019. FDRs, if any, be returned.*

7. AND WHEREAS, the Withdrawal order was issued on 07.09.2017. The institution filed an appeal to the appellate authority.

8. AND WHEREAS, the appeal order dated 12.09.2018, "... concluded that the matter deserved to be remanded to the W.R.C. for revisiting the matter, after the Appellant Institution submits required documents and taking further action expeditiously. NOW THEREFORE, the Council hereby remands back the case of Shethkari Shikshan Prasarak Mandal College of Physical Education, Ashit City, Ashit, Maharashtra to the WRC NCTE for necessary action as indicated above."

9. AND WHEREAS, the Institution submitted the compliance of the appeal order which was received on 26.09.2018.

10. **AND WHEREAS**, the matter was placed in the 299th meeting held on October 30-31 and November 01, 2018, of WRC, and the committee decided that "...This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter, after the appellant institution submits the required documents and taking further action expeditiously.

On perusal of the reply dated 24.09.2018 of the institution, the committee observed that:-

- The institution has submitted the staff list of only one Incharge Principal. The faculty required as I. per Appendix 7 of NCT Regulations, 2014 is not submitted.
- FDR for Rs. 12.00 lakhs as required under clause 10(1) of NCTE Regulations, 2014 not submitted. II. Ш.
 - Building Completion Certificate duly signed by competent authority submitted.

Hence, the Committee decided that Show Cause Notice be issued to the Institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17(1) of the NCTE Act, 1993."

The Show Cause Notice was issued to the institution on 14.11.2018 and the reply received on 23.11.2018. 11.

WHEREAS, the matter was placed in 374th meeting of WRC held on October 18-19, 2022 and the 12. committee examine the documents submitted by the institution has complied with the requirements laid down under NCTE regulation and decided that the recognition granted to the institution for B.P.ED course with an annual intake of 100 students (one unit) be restored from the date of issue of this order.

NOW THEREFORE, the Western Regional Committee hereby restored recognition of Shethkari Shikshan Prasarak Mandal College of Physical Education, Ashti City, Ashti, Maharashtra for B.P.ED course with an annual intake of 100 students (one unit), to be restored from the date of issue of this letter.
