RESTORATION ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely KAMDHENU BAHUUDDESHIYA SEVABHAVI SANSTHAS B.ED. COLLEGE, GUT NO. 238, JATWADA, JATWADA ROAD, DIST. AURANGABAD-431003, MAHARASHTRA vide order No. WRC/5-6/110/2008/46956-46961 dated: 26.11.2008 for conducting B.Ed. (MARATHI) CO-ED course with an annual intake of 100 students.

- 2. **AND WHEREAS**, the Revised Recognition order was issued to the institution vide dated **31.05.2015** for B.Ed. course with an annual intake of 100 students with a direction to submit the compliance to the Revised Recognition order on or before **31.10.2015**.
- 3. As no compliance to the revised recognition order was received, the matter was considered by WRC in its **255**th **meeting** and as per the decision of WRC, Show Cause Notice for non-submission of compliance was issued vide dated: **17.03.2017**.
- 4. The institution has not submitted any reply to the Show Cause Notice dated 17.03.2017. The matter was considered by WRC in its 311th meeting, wherein the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.

Accordingly, withdrawal order was issued to the institution on 10.10.2019.

5. **AND WHEREAS**, The institution has filed Court Case in the Hon'ble High court of Delhi at New Delhi vide W.P. No. 11523/2019 and CM Appl. 47329/2019 and the order of the Hon'ble High court in above Writ Petition was considered by WRC in its 312th meeting held on 27th to 29th January, 2020 and the committee decided as under:

The Committee studied the decision of the Hon'ble High Court in the W.P. No. 11523/2019 & CM Appl No. 47379/2019. The Committee decided that

A copy of SCN dated 17.03.2017 may be sent to the institution again. The representative of the institution be given personal hearing in the next meeting of WRC. The date of the personal hearing will be intimated later.

The representative alongwith all the requisite documents be remain present.

6. **ACCORDINGLY**, the Communication letter was issued to the institution on 07.02.2020.

7. **AND WHEREAS**, the matter was considered by WRC in its **313**th **meeting**, wherein the committee decided as under: -

As per the decision of WRC in its 312th meeting in compliance of the Court directions, the representatives of the institution appeared before WRC for personal hearing on 26/02/2020. It is decided after the discussion that the representative of the institution will submit the required documents today itself.

8. **AND WHEREAS**, the institution has submitted the reply on dt. 26/02/2020 to the Communication letter dated 07.02.2020. The matter was considered by WRC in its **315**th **meeting**, held on 10th to 11th and 14th August 2020 wherein the committee decided as under: -

"This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing.

The personal hearing of the institution was held on 26th February 2020, wherein the petitioner wherein the petitioner informed that it had submitted certain documents to WRC Office.

The WRC examined the documents submitted by the institution and observed the following deficiencies: -

From the staff list submitted, the staff at Sr. No. 12 and 13 are not qualified as per NCTE Regulations 2014, as amended vide notification dated 09.06.2017. The Non-Encumbrance Certificate is to be issued by Competent Revenue Authority.

The Land Use Certificate is to be issued by the Competent Revenue Authority.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act."

- 9. Accordingly, Final Show Cause Notice was issued to the institution on 02.09.2020.
- 10. **AND WHEREAS,** the matter was considered by WRC in its **321**st **meeting**, held on 09th to 11th November 2020 wherein the committee decided as under: -

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under:

Recognition of the institution be continued for B.Ed. programme.

11. **NOW THEREFORE**, the recognition granted to the institution for conducting B.Ed. course has been restored as per decision of the WRC in its 321st meeting and institution is permitted to continue the existing B.Ed. course.

12. The institution shall continuously adhere the NCTE Regulations, 2014 as amended time to time and any deviation from it shall be liable for action, against the institution, as stipulated under NCTE Act, Rules and NCTE Regulations.
