RESTORATION ORDER 200 617

WHEREAS, recognition was granted to the institution, namely, Shri V.I. Patel College of Education, New India Colony, Nikol-Naroda Road, Nikol, Ahmedabad, Gujarat - 382350 under section 14 of NCTE Act, 1993 for conducting **B.ED.** course with an annual intake of 100 students vide order no. WRC/NCTE/2006-2007/C-20183 dt. 10.07.2018 and WRC/5-6/99<sup>th</sup>/2007/C-21364 dt. 06.08.2007.

- 2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Shri V.I. Patel College of Education, New India Colony, Nikol-Naroda Road, Nikol, Ahmedabad, Gujarat - 382350 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.
- And whereas, after the receipt of affidavit dt. 10.01.2015 from the institution, a revised recognition order no. WRC/APW04222/323418/2015/139458 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic unit of 50 students) from session 2015-16.
- And Whereas, the matter was placed before the WRC in its 255<sup>th</sup> Meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt. 08.08.2016.
- 5. And whereas, institution had not submitted any reply in response to show cause notice dt. 08.08.2016 and the matter was placed before the WRC in its 294th meeting held on July 04–05, 2018 and the Committee decided as follows:-

"The case file was seen. Show Cause Notice was issued to the institution on 08.08.2016 and the institution has not replied.

Hence, Recognition is withdrawn."

- And Whereas, a withdrawal order no. WRC/APW04222/323418/Guj./294<sup>th</sup>/2018/199197 dt. 10.07.2018 was issued to the institution.
- And Whereas, the institution has filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 12.09.2018 has decided as follows:-

"After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the committee concluded that the matter deserved to ne remanded to the W.R.C. for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

The Council hereby remands back the case of Shri V.I. Patel College of Education, School Building, Near Ankur Tnament, New India Colony, Nikol Naroda Road, Ahmedabad, Gujarat to the WRC, NCTE, for necessary action as indicated above."

And Whereas, reply dt. 24.09.2018 of institution was placed before the WRC in its 299<sup>th</sup> meeting held on October, 30 – November 1, 2018, and Committee decided as follows:-

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter and after the appellant submits required documents and taking further action expeditiously.

The institution vide reply dated 24.09.2018 has requested for reduction of intake from two units to one unit. On perusal of the reply, the Committee observed that:-

- (i) The institution has submitted the approved staff list of 1+9 faculty members (excluding librarian).
- (ii)FDR for Rs.12.00 lakhs as required under clause 10(1) of NCTE Regulations, 2014 submitted.

Hence, the Committee decided that Recognition of the institution be restored and reduced for one unit of B.Ed. course."

- 9. Now Therefore, this restoration order is issued as per decision of the WRC in its  $299^{th}$  meeting as cited above.
- Contravention of any of the provisions of the NCTE Act, 1993, NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution. as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
