WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has acrified the Regulations, 2014 on 01.12.2014.

- AND, WHEREAS, the recognition has been granted to the institutions mentioned in para 5 below for the course mentioned against their name.
- AND, WHEREAS, the said institutions by affidavit have consented to come under New Regulations and have sought for the number of units in B.Ed./B.P.Ed./M.Ed. as mentioned in para 5 below against their name, which may require additional facilities.
- AND, WHEREAS, it has been decided to permit the institution to have the desired number of units subject to fulfilling the following conditions:-

The institution shall create additional facilities that include (a) additional built-up-area, (b) (i) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

The applicant Institution for additional unit will be required to submit the required (ii) documents, such as, land documents, Non Encumbrance Certificate (EC), Change of Land Use Certificate (CLU) and Building Plan (BP) in the specified proforma available on the website of the Regional Committee in proof of having provided the additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given to the Visiting Team at the time of

The Regional Committee shall arrange for verification of documents, inspection of the (iii) premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution has failed to comply with these requirements, the nstitution shall not be permitted to admit students for the academic year 2016-2017.

n case any existing institution's matter is sub-judice under court direction/SCN under (iv) section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite cocuments as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. This order shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case and in respect of Section 17/complaint cases etc. as decided ty the Northern Regional Committee.

- (h) Number of books in the library, journals subscribed to and additions, if any, in the last cuarter.
- (i) The affidavit with enclosures submitted along with application.
- (j) The institution shall be free to post and additional information, if it so desires.
- 10. Any false or incomplete information on the website of the institution shall render the institution liable for withdrawal of recognition.
- If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there-under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

### ORDER

Act, 1993, the Regional Committee hereby grants recognition to Pacific College of Teachers Education, Pratap Nagar Extension, Airport Road, Debari, Udaipur (Raj.) 313001 for B.Ed. Course with an annual intake of 100 seats (One Hundred), w.e.f. 23" July 2005 subject to compliance of the following conditions before commencement of the academic session.

a. Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./UGC is to be completed before the commencement of the session.

b. The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session.

c. The institution shall adhere to all the other regulations and guidelines as framed by NCTF from time to time.

d. The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.

e. That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of Issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.

f. Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993

The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the and of each academic year along with a copy of the approval of the affiliating University State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
