WHEREAS Swami Vivekanand College Run By Prakhar Pragya Shiksha Prasara Evam Samaj Kalyan Samiti, Sironja, Bika Bamhori, Sagar - 470228 Madhya Pradesh has been recognized by WRC conducting B.ED. course with an annual intake of 100 students (two basic units of 50 students each) vide order No. WRC/5-6/105th/2008 dated 18.08.2008, WRC/5-6/106th/2008/40174 date 26.08.2008, B.P.Ed. Course vide order No. WRC/5-6/113/2008/49536-49541 dated 13.01.2009 & D.Ed. Course vide order No. WRC/5-6/105/2008/39021 dated 18.08.2008.

2. **AND WHEREAS**, the Revised Recognition order was issued to Swami Vivekanand College Run by Prakhar Pragya Shiksha Prasara Evam Samaj Kalyan Samiti, Sironja, Bika Bamhori, Sagar - 470228 Madhya Pradesh for B.Ed Course vide order No. WRC/APW06701/223712/2015/dt. 31.05.2015 with an annual intake of 100 students, B.P.Ed Course vide order No. WRC/APW06707/224165/2015/136133 date 20.05.2015 with an annual intake of 100 students.

3. **AND WHEREAS**, permission for change of Affiliating Body was permitted by WRC vide order No. APW06701/223712/233rd/2015/154150-4158 date 16.10.2015 for B.Ed. course, vide order No. WRC/5-6/APW06707/224165/233rd/2015/154399-4407 dated 21.10.2015 for B.P.Ed. course & vide order No. WRC/5-6/APW06708/222371/233rd/2015/154299-4307 date 20.10.2015 for D.Ed. course.

4. **AND WHEREAS**, the institution / University vide representation dated 05th March 2020 requested to permit the change of affiliating body from the date of Gazette Notification notifying the University i.e. 31.12.2011.

5. **AND WHEREAS**, the matter was considered by WRC in its 324th Meeting held on 23rd and 24th and December 2020 and WRC decided (Ref: Sl. No. 17, Page No. 15-16 of 324th WRC Minutes) as under: -

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

1. The institution has become a part of the University vide Gazette Notification dated 31.12.2011.
2. The WRC noted that NCTE had permitted the institution to become a part of the University vide order dated 16.10.2015.
3. The institution has requested for permission of affiliating body from the academic session 2012-2013 from Dr. Hari Singh Gaur University, Sagar to Swami Vivekanand University, Sagar.

The WRC considered the matter and decided that the change in affiliating body of the institution be permitted from the date of Gazette Notification establishing the University by the Government of Madhya Pradesh"

NOW THEREFORE, as per decision of WRC in 324th meeting held on 23rd-24th and 31st December 2020, permission is hereby granted for change of University from Dr. Hari Singh Gour Vishwavidyalaya Sagar, M.P to Swami Vivekanand University Sagar, M.P. for B.Ed., B.P.Ed. course & from M.P Board of Secondary Education to Swami Vivekanand University Sagar, M.P for D.El.Ed course, from the date of establishing the University by the State Government of Madhya Pradesh act No.44 i.e. 31.12.2011.
