AND WHEREAS, permission for change of Affiliating Body was permitted by WRC vide order No. APW06701/223712/233<sup>rd</sup>/2015/154150-4158 date 16.10.2015 for B.Ed. course, vide order No. WRC/5-6/APW06707/224165/233<sup>rd</sup>/2015/154399-4407 dated 21.10.2015 for B.P.Ed. course & vide order No. WRC/5-6/APW06708/222371/233<sup>rd</sup>/2015/154299-4307 date 20.10.2015 for D.Ed. course.
- 4. **AND WHEREAS,** the institution / University vide representation dated 05<sup>th</sup> March 2020 requested of to permit the change of affiliating body from the of date of Gazette Notification notifying the University i.e. 31.12.2011.
