 - Number of books in the library, journals subscribed to and additions, if q) h) any, in the last quarter.
 - The affidavit with enclosure submitted along with application.
 - The institution shall be free to post additional relevant information. if it 1) j)
 - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
 - In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition.
