WHEREAS, the institution, namely, Smt. K.B. Patel Vidya Sankul Palasar Shelavi Station, Ta-Chansma, Dist.-Patan, Gujarat was granted recognition by WRC, NCTE for B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/99th/2007/C-22612 dated 21.08.2007.

- 2. AND WHEREAS, the matter was placed before 105th WRC meeting and resolved to approve the request for change in the name of the institution from Smt. K.B. Patel Vidya Sankul to Shri R.J. Patel College of Education, Palasar Shelavi Station, Ta-Chansma, Dist.-Patan, Gujarat.
- 3. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution viz. Shree R.J. Patel College Of Education, Palasar Shelavi Station, T.A- Chansma, Dist.-Patan, Gujarat vide order No. WRC/APW02082/323238/2015/144933,36,43,48,52,68,73,79 dated 31.05.2015 for conducting B.Ed. programme with an annual intake of 100 students.
- 4. **AND WHEREAS,** the matter regarding compliance of conditions of revised recognition order was considered by WRC in its 255th meeting held on 22-24 June, 2016 and accordingly, Show Cause Notice was issued to the institution dated 24.08.2016.

- 5. **AND WHEREAS**, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 02.09.2016 received in WRC on 07.09.2016.
- 6. **AND WHEREAS**, the matter was considered by WRC in its 277th meeting held on June 29-30, 2017 and the committee decided as under:-
 - "...The case file was seen. In response to the WRC letter dt. 29/08/2016, regarding fulfilment of requirements, the institution has opted for 1 unit of the B.Ed. course. It has not submitted any documents (their letter 18/16-17 dt. 02/09/2016).

However, the institution is required to submit the following:-

- a) List of 1 Principal and 7 faculty members qualified and approved by the affiliating body for the current session as per NCTE Regulations, 2014.
- b) In addition the institution is required to submit the documents regarding FDRs as per NCTE Regulations, 2014.

Show Cause Notice be issued on the above grounds. Reply should be received within 1 month.

Accordingly, a show cause notice was issued to the institution on 05.07.2017.

- 7. **AND WHEREAS**, in response to show cause notice, the institution has submitted reply vide letter dated 24.07.2017 received in WRC on 07.08.2017 and letter dated 27.09.2017 received in WRC on 29.09.2017.
- 8. **AND WHEREAS**, the matter was considered by WRC in its 285th meeting held on December 19-21, 2017 and the Committee decided as under:-
 - "...The case file was seen. Show Cause Notice was issued to the institution on 05.07.2017. The institution replied on 24.07.2017 & 27.09.2017. The institution has submitted a staff profile of 7 faculty members. Principal has not been appointed.

Building Completion Certificate in the prescribed format and counter signed by a Govt. Engineer not submitted.

Therefore, Recognition is withdrawn from the academic session 2018-2019."

Accordingly, a withdrawal order was issued to the institution on 02.01.2018.

- 9. **AND WHEREAS**, institution filed an appeal before the Appellate Authority at NCTE, New Delhi and the Appellate Authority vide order dated **05.06.2018** remanded back the case to WRC. In compliance of appeal order the reply submitted by the institution vide letter dated 07.06.2018 received in WRC on 07.06.2018.
- 10. **AND WHEREAS**, the matter was considered by WRC in its 294th meeting held on July 04-05, 2018 and the Committee decided as under:-
 - "...The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 05.06.2018 has remanded the case to WRC.

The institution vide letter dated 07.06.2018 has submitted the required documents except for FDRs for Rs.12.00 lakhs in the joint name with the Regional Director.

As soon as the FDRs are submitted, Restoration order will be issued by Regional Director.

Accordingly, a letter was issued to the institution on 11.07.2018.

- 11. **AND WHEREAS**, vide letter dated 23.07.2018 the institution has submitted the FDRs of Rs. 12 lakh.
- 12. **NOW THEREFORE**, in terms of above decision of WRC, the recognition of the Shri R.J. Patel College of Education, Palasar Shelavi Station, TA-Chansma, Dist.-Patan, Gujarat for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) is hereby restored.

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dated 31.05.2015.
