Whereas, in terms of section 15(1) of the NCTE Act, 1993, District Institute of Education and Training, 492/A, Near Mahi Canal, Valasan, Anand, Gujarat - 388326 had submitted on 11.13.2013 the application to the Western Regional Committee of the NCTE for grant of permission to District Institute of Education and Training, 492/A, Near Mahi Canal, Valasan, Anand, Gujarat - 388326 for B.Ed. course.

And whereas, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 1.12.2014.

And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 289th meeting held on 01st and 03rd March, 2018 is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

Now therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993 and in accordance with the NCTE Regulations, 2014, the Western Regional Committee, (NCTE), hereby grants permission to District Institute of Education and Training, 492/A, Near Mahi Canal, Valasan, Anand, Gujarat - 388326 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one unit of 50 students) from the academic session 2018-19.
