ORDER

In terms of Section 14 (1) of the NCTE Act, 1993 JG College Of Education For Women, Asia Charitable Trust Asia Campus, Thaltej Ahmedabad had submitted an application to the Western Regional Committee of NCTE for grant of recognition for starting B.Ed. of one year from the academic session 2003-2004 with an annual intake of 100 students.

- On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - The institution has acquired the land for setting up the teacher education institution.
 - The institution has constructed the building for conducting the course on the above (11) mentioned land.

- Let The institution has made arrangements for conducting the course in rented premises.
- The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund (iii) of Rs.3.00 lakhs.
- The institution has initiated the process for recruitment of Principal/Head of (iv) Department and teachers for the said course.
- Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 3. 1993, the Regional Committee hereby grants recognition to JG College Of Education For Women, Asia Charitable Trust Asia Campus, Thaltej Ahmedabad for B.Ed. of one year from the academic session 2003-2004 with an annual intake of 100 students subject to fulfillment of the following.
- The institution shall ensure that it gets duly affiliated for this course to the concerned (1) University and all other formalities required by the University are also completed before the commencement of the course and admission of the students to the course and a report to this effect should be sent to the Committee.
- That the institution will ensure that 08 (one Principal and 07 lecturers) faculty members are in (6) position for an intake of 100 students before commencement of the course and a report to this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- The institution shall within one month of the receipt of recognition create an endowment fund (c) account into a joint account to be operate! along with an official of the Regional Committee
- The institution shall shift to its own premises within three years from the date of recognition (d) (In case the course is started in rented premises).
- The institution shall comply with the various other norms and standards as prescribed in the (e) NCTE Regulations.

- 4. Recognition is subject to the condition that the affiliating University shall ensure that, among of things, an institution has appointed required number of faculty members (including Principal/Ho of Department) as per the norms of the NCTE/State Government.
- 5. Further, the recognition is subject to the fulfillment of all such other requirements as may prescribed by other regulatory bodies like UGC and State Government, etc.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of ea academic year along with a copy of the approval of the affiliating university/State Directorate Education to the appointment of faculty members and the statement of annual accounts du audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCT Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee ma withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
