Whereas, the WRC had granted recognition to the Institute of Language Teaching (Grant-in-Aid College), Udyognagar, Jamnagar, Gujarat - 361008 for conducting B.Ed. course of one year duration with an annual intake of 30 students vide order no WRC/5-6/2k/12090 dt. 29.12.2000.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Institute of Language Teaching (Grant-in-Aid College), Udyognagar, Jamnagar, Gujarat - 361008 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 06.01.2015 from the institution, a revised recognition order no. WRC/313040/2015/143477 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course of two year duration with an annual intake of 50 seats (one basic unit of 50 students) from session 2015-16.

And whereas, the Deptt. Of Education, Govt. of Gujarat, Sachivalaya, Gandhinagar vide letter no.SA/YA/JA/1584/29(200/KH1) dt. 05.06.2017 granted approval for shifting of premises of Language Teaching (Govt. Aided Instt.) from Jamnagar to Rajkot.

And whereas, the institution vide letter no. dt. 12.07.2017 submitted an application for shifting of premises from Udhyognagar, Jamnagar, Gujarat to Plot No. 1, Survey No. 442, Kalawad Road, Rajkot, Gujarat.

And whereas, the matter was placed before the WRC in its 278<sup>th</sup> meeting held on July 25<sup>th</sup> – 26<sup>th</sup>, 2017 and the Committee decided as follows :-

"The case file was seen. WRC in its 277th meeting had asked the institution to apply for shifting and submit all the documents as required under NCTE Regulations, 2014. The institute vide letter dt. 12.07.2017 has submitted the application as well as various documents.

Hence, VT be constituted."

And whereas, the inspection of the institution was conduct on 16.09.2017 and visiting team report was received by the WRC.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 282<sup>nd</sup> meeting of WRC held on October, 24<sup>th</sup>-26<sup>th</sup>, 2017 and the committee decided as follows :-

"The case file was seen. The Govt. of Gujarat had permitted the shifting of the Institute of Language Teaching, Jamnagar to Rajkot. Accordingly, VT was sent on 16.09.2017 and VT has recommended the shifting.

Therefore, shifting is permitted."

Now therefore, in exercise of the powers vested under section 8(9) of NCTE Regulations, 2014, permission is hereby granted for change of premises of Institute of Language Teaching ( Grant-in-Aid College) from Udhyognagar, Jamnagar, Gujarat to Plot No. 1, Survey No. 442, Kalawad Road, Gujarat.
