Recognition Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 SARVODAY COLLEGE OF EDUCATION, B.ED.DIVISION, SARVODAY EDUCATION & CHARITABLE TRUST, S.D.(SAMAL DEVI)-DEROL STATION, KANOD PINGLI ROAD, TAL. KALOL, DIST. PANCHMAHAL, GUJARAT. has submitted an application (Code No.- APW04062/323398) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting B.ED.(CO.ED.) course with an annual intake of 100 students on 29-Nov-2006.

2. AND WHEREAS in its 110th meeting held on November 12-14, 2008 the Western Regional Committee after considering the report of the visiting team carried out u/s 17 of NCTE Act as well as other relevant materials furnished by the applicant institution decided to withdraw recognition of the institution for B.ED.(CO.ED.) Course from the academic session 2009-2010 and accordingly the withdrawal order no. WRC/APW04062/323398/WRC/110/2008/48783 dated 23/12/2008 was issued on the institution.

3. AND WHEREAS the correspondent, SARVODAY COLLEGE OF EDUCATION, B.ED.DIVISION, SARVODAY EDUCATION & CHARITABLE TRUST, S.D. (SAMAL DEVI)-DEROL STATION, KANOD PINGLI ROAD, TAL. KALOL, DIST. PANCHMAHAL, GUJARAT. has preferred an appeal to NCTE New Delhi against the decision of WRC withdrawn recognition under section 18 of the NCTE Act, 1993 against the said Order.

4. AND WHEREAS having considered the oral submission by the representative of the institution, the written representation, the record of the case and V.T. Report, the Appellate Authority decided to reverse the order of NCTE, WRC. Accordingly, the appeal was accepted with direction to WRC to grant recognition to the institution immediately.

5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993 and as per the NCTE, New Delhi Order No. F.No. 89-404/2008/Appeal dated 09.02.2009 the Western Regional Committee hereby grants recognition to SARVODAY COLLEGE OF EDUCATION, B.ED.DIVISION, SARVODAY EDUCATION & CHARITABLE TRUST, S.D.(SAMAL DEVI)-DEROL STATION, KANOD PINGLI ROAD, TAL. KALOL, DIST. PANCHMAHAL, GUJARAT. for conducting B.ED course of SEC of 1 year duration with an annual intake of 100(SEC) from the academic session 2009-2010 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulation 2007 from academic session 2009-2010.

6. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.

7. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

8. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

9. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

10. Further, subject to the provision of NCTE Act 1993, the institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, applicable.

11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:

- (i) Copy of the Application Form
- (ii) Land and Building Particulars.
- (iii) Staff Profile.
- (iv) Recognition letter.
- (v) Information for having fulfilled the norms & standard and other required conditions.

13. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
