Whereas, the WRC had granted the recognition to Smt. S.I. Patel Ipcowala College of Education, Sainath Road, Petlad, Kheda, Gujarat - 388450 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/22/2000/8383 dt. 17.10.2000.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Smt. S.I. Patel Ipcowala College of Education, Sainath Road, Petlad, Kheda, Gujarat - 388450 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 10.01.2015 from the institution, a revised recognition order no. WRC/313014/2015/140794 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 50 seats (one basic unit of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255th meeting held on June 22nd - 24th, 2016 and the Committee decided to issue Show Cause Notice dt. 10.08.2016.

And whereas, reply dt. 29.08.2016 was submitted by the institution placed before the WRC in its 283rd meeting held on November 14th - 15th, 2017 and the Committee decided as follows :-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile (1+7) approved by the affiliating body not submitted in original.

Building Completion Certificate signed by a Govt. Engineer and FDRs of Rs.12.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

And whereas, the institution was informed vide letter no. WRC/313014/B.Ed./283rd/GUJ/2017/193193 dt. 21.11.2017.

And whereas, reply dt. 07.12.2017 was submitted by the institution was placed before the WRC in its 288th meeting held on February 15th - 16th, 2018 and the Committee decided as follows :-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice was issued followed by a compliance letter dated 21.11.2017. The institution has submitted a staff list of only 1+4 faculty members, which is not as per NCTE Regulations, 2014.

Hence, Recognition is withdrawn from the academic session 2018-2019."

Now, therefore, the recognition of Smt. S.I. Patel Ipcowala College of Education, Sainath Road, Petlad, Kheda, Gujarat - 388450 for conducting B.Ed. programme of two years duration with an annual intake of 50 seats (one basic unit of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
