WITHDRAWAL ORDER

WHEREAS, recognition/permission was granted to the institution Sri Sanskardham B.Ed. College, Late Shri Ratansinhji Sodhe Charitable Trust, Rail Nagar Society, 3, Bajrangwadi Main Roads, Jamnagar Road, Rajkot 360006, Gujarat, under Section 14 of NCTE Act, 1993 for conducting B.ED course with an intake of 100 vide order No. WRC/5-6/88/2006/C-11468 dt.1.03.2007.

- 2. And whereas, the recognition was withdrawn vide order No.WRC/APW02258/323253/110/2008/48369 dt. 19.12.2008 as per decision of 110rd meeting of WRC.
- 3. And whereas, the matter was considered by WRC in its 145th meeting in the light of the direction of the Hon'ble High Court of Gujarat at Ahmedabad in SCA No.3205/2009 and related matters and decided to cause inspection. The inspection of the institution was conducted on 26.03.2011. The VT report was placed in 148th meeting of WRC and the Committee noted that the following deficiencies exist vis-à-vis NCTE norms:-
 - 1. Land document submitted shows that the land is meant for residential purpose.
 - 2. There is a mismatch in the building plan submitted at the time of application and second time (present).
 - 3. Duly approved staff list not submitted.
 - 4. The land documents duly certified by the compotent authority was not submitted along with the application that was required as per the section 7(d) of NCTE Norms and Standards 2002 or as per Section 8(5) of NCTE Norms and Standards 2005.
- And whereas the Show cause notice was issued to the institution vide letter No. APW02258/323253/148/2011-77943 dt. 30.04.2011.
- AND WHEREAS, the reply submitted by the institution was considered by the WRC Committee in its 151st meeting held on 27-29th ,June, 2011 and having taken into consideration all relevant facts of the case, it was decided to withdraw recognition for conducting B.ED Course from the academic session next following the date of this withdrawal order
- Now, therefore, recognition to Sri Sanskardham B.Ed. College, Late Shri Ratansinhji Sodha Charitable Trust, Rail Nagar Society, 3, Bajrangwadi Main Roads, Jamnagar Road, Rajkot 360006, Gujarat for B.ED course in terms of Section 17(1) of the NCTE Act, 1993 is hereby withdrawn from the session next following the date of withdrawal order on the following grounds:-
 - 1. Principal has not been appointed.

- 7. The affiliating body/State Govt. are advised not to admit/allot any student to Sri Sanskardham B.Ed. College, Late Shri Ratansinhji Sodha Charitable Trust, Rail Nagar Society, 3, Bajrangwadi Main Roads, Jamnagar Road, Rajkot 360006, Gujarat. As per Section 17(4) of NCTE Act, 1993, the qualification in teacher education obtain d pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.
- 8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines or appeal are enclosed herewith.
