

#### **ORDER**

Whereas recognition was granted to SRI SANSKARDHAM B.ED. COLLEGE, LATE SHRI RATANSINHJI SODHA CHARITABLE TRUST, RAIL NAGAR SOCIETY, 3, BAJRANGWADI MAIN ROADS, JAMNAGAR ROAD, RAJKOT 360006, GUJARAT under section 14 of NCTE Act, 1993 for conducting B.ED course vide order WRC/5-6/88/2006/c-11468 dtd. 01.03.2007 with an annual intake of 100 students.

And whereas, the recognition was withdrawn vide order No.WRC/APW02258/323253/110 $^{th}$ /2008/48368-48373 dt. 19.12.2008 as per decision of 110 $^{th}$  meeting of WRC.

And whereas, the matter was considered by WRC in its 145<sup>th</sup> meeting in the light of the directions of the Hon'ble High Court of Gujarat at Ahmedabad in SCA No.3205/2009 and related matters and decided to cause inspection. The inspection of the institution was conducted on **26.03.2011**. The VT report was placed in **148**<sup>th</sup> meeting of WRC and the Committee decided to issue show cause notice.

And whereas the show cause notice was issued to the institution vide letter No.APW02258/323253/148/2011-77943 dt. 30.4.2011.

And whereas, the reply submitted by the institution in the office of WRC on 02.06.2011 was placed in 151<sup>st</sup> meeting of WRC held on 27<sup>th</sup> -29<sup>th</sup>, June, 2011. WRC decided to withdraw recognition for conducting B.ED. Course from the end of the academic session next following the date of the withdrawal order on following points:-

### 1. Principal has not been appointed.

And whereas, withdrawal order was issued to the institution vide this office order No.APW02258/323253/151/201/80331-80336 dt. 28.7.2011.

And whereas, the institution had again approached High Court (SCA No. 10200/2011) and the order passed by Hon'ble High Court dt. 2.9.2011 was placed in 155<sup>th</sup> meeting of WRC.

And whereas, the committee again reconsidered the matter in its  $155^{th}$  meeting held on  $18^{th} - 20^{th}$  October, 2011 as per above court direction and the Committee permitted to continue the recognition of the said institution with same terms and conditions as mentioned in the recognition order **dt.** . **01.03.2007.**
