Whereas, the recognition was granted to the institution, namely, SMT. VALIBA R. PATEL B.ED. COLLEGE, SARDAR PATEL CAMPUS, MODASA HIGHWAY ROAD, LUNAWADA, PANCHMAHAL – 389230, GUJARAT for B.ED course vide order No.WRC/5-6/98/2007/C-20325-20332 dated 26.07.2007.

And whereas the inspection of the said institution under Section 17 was conducted by the visiting team on 07.09.2010. The report of the visiting team was considered by the WRC and the committee decided to issue show cause notice u/s 17 of NCTE Act, 1953. Accordingly, show cause notice was issued on 23.09.2010.

And, whereas, the institution has submitted reply to the show cause notice sought vide this office letter No.WRC/APW04432/323437/140/2010/70870 dt.23.09.2010. The matter was placed before the Western Regional Committee in its 152nd meeting held on July, 10th -12th, 2011 and having taken into consideration all the relevant facts of the case, the Committee decided that recognition for B.ED Course be withdrawn on the following grounds:-

1. Lease agreement is not duly certified by the competent authority.

Now, therefore, the recognition to SMT. VALIBA R. PATEL B.ED. COLLEGE, SARDAR PATEL CAMPUS, MODASA HIGHWAY ROAD, LUNAWADA, PANCHMAHAL – 389230, GUJARAT for the B.ED course in terms of Section 17(1) of the NCTE Act, 1993 is hereby withdrawn from the end of academic session next following date of this withdrawal order.

The affiliating body/State Govt. are advised not to admit/allot any student in B.ED in the said institute. As per Section 17(4) of the NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University or in any school, college or other educational body aided by the Central Government or any State Government.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
