Restoration of Recognition Order

Whereas, recognition was granted to the institution namely **SMT. VALIBA R. PATEL B.Ed. COLLEGE, B-8, SARDAR PATEL NAGAR, MODASA HIGHWAY ROAD, LUNAWADA, PANCHMAHAL – 389230, GUJARAT**, for conducting **B.Ed. (Co-Ed)** course vide order no. /WRC5-6/98th/2007/ C-20325-20332 dt. 26.07.2007.

And whereas, complaint received against institution then matter placed in 137th meeting and committee decided to VT be constituted for caused comprehensive inspection for all courses under section 17 (1).

And whereas, the inspection of institute was conducted on **07.09.2010**.

And whereas, the visiting team report was placed in **140th** meeting of WRC and the committee decided to issue Show Cause Notice **u/s 17** of NCTE Act, 1993 be issued to the institution on **23.09.2010**.

And whereas, the reply dt. **24.06.2011** was placed in **152nd** meeting of WRC and committee decided to recognition is withdrawn **u/s 17** of NCTE Act, 1993 Withdrawal order issued on **26.09.2011**.

And whereas, against withdrawal order, the institution preferred an appeal **u/s 18** of NCTE Act, 1993 and the Appellate Authority vide its order dt. **03.11.2011** the Council hereby reverses the order of WRC.

And whereas, the committee consider the matter in **158th** and decided that in the light of appeal order passed by the NCTE hqrs. and committee decided to issued Show Cause Notice to the institution on 19.03.2012.

And whereas, reply dt. 23.04.2012 & 21.04.2012 submitted by institution as per direction of Appellate Authority was placed in 167th meeting of WRC and committee decided to legal opinion on **16.08.2012**.

Thereafter, the institution filed a Writ Petition under SCA No. -10497/2013 in the Hon'ble High Court of Gujarat at Ahmedabad order dt.22.07.2013.


