Sir/Madam,

With reference to the above, it is to inform that as per NCTE Regulations, 2014 a revised recognition order no. WRC/APW04432/323437/2015/145110 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course of two year duration with an annual intake of 50 seats (one unit of 50 students) from session 2015-2016.

The WRC in its 293rd meeting held on June 12th - 14th, 2018 considered the reply dt. 10.10.2017 submitted by the institution, for compliance of conditions as mentioned in the revised recognition order dt. 31.05.2015 and decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 11.09.2017 was issued.

The institution in its reply dated 10.10.2017 has submitted a staff profile of 1+9 faculty members in original. Building Completion Certificate and FDRs for Rs. 12.00 lakhs submitted.

Hence, permitted to continue."

Therefore, the revised recognition order no. WRC/APW04432/323437/2015/145110 dt. 31.05.2015 issued by the WRC for conducting B.Ed. course of two year duration with an annual intake of 50 students (one basic unit of 50 students) will remain continue.

It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
