Whereas, recognition was granted to the institution **Smt. L.M. Patel Women B.Ed. College, B-8, Sardar Patel Nagar, Modasa Road, Lunawada (W.R.)- 389230, Gujarat** under Section 14 of NCTE Act, 1993 for conducting B.ED course with an intake of 100 from academic session 2005-2006 vide order No. WRC/2-32/74/323205/2005/4998 dt. 06.06.2005.

2. And whereas the institution of the institution was conducted on **7.09.2010** under section 17 of NCTE Act, 1993 and the visiting team report was considered by WRC and decided to issue show cause notice on 27.09.2010.

3. And Whereas, the reply submitted by the institution was considered by the WRC in its 143rd & 147th meeting of WRC whereby the Committee decided to seek clarification on following points:-

- 1) **The college is deficient of one teaching staff.**
- 2) **As per the letter No.WRC/323205/2010/69042 dt.8.07.2010 of NCTE WRC. The institution was requested to disaffiliate from SNDT University and affiliate with Local University having Jurisdiction in the location of the college.**
- 3) **Staff list not approved by the affiliating University.**

4. And Whereas, the WRC directed that an opportunity be given to the institution to make a written representation within 30 days from the date of issue of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, letter was issued to the institution on 25.01.2011 & 8.04.2011 respectively.

5. And whereas, the reply submitted by the institution was considered by the Western Committee in its 150th meeting held on 2nd-4th, June, 2011 and having taken into consideration all the relevant facts of the case, it was decided to withdraw recognition for conducting B.ED Course from next academic session i.e. 2011.2012 on the following grounds:-

1) **For non compliance of the order to obtain affiliation of the local University after de-affiliation from the SNDT University.**

6. Now, therefore, recognition to **Smt. L.M. Patel Women B.Ed. College, B-8, Sardar Patel Nagar, Modasa Road, Lunawada (W.R.)- 389230, Gujarat** for the B.ED course in terms of Section 17(1) of the NCTE Act, 1993 is hereby withdraw from the end of the academic session next the following date of this order.

7. Affiliating Body/State Govt. are advised not to admit/allot any student in B.ED course in the said institute. In accordance to the Section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.
