(Co-Ed) course with an annual intake of 100 seats.

- 2. And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, laboratory and that it fulfills such other conditions required for proper functioning of the institution for **B.Ed.** (**Co-Ed**), as determined by clause 7(9) of NCTE Regulations, 2009, and decided to issue letter of intent dated. **11.02.2014.**
- 3. And whereas, reply dated **02.03.2014** submitted by the institution was considered by WRC in its **203**<sup>rd</sup> meeting held on **March 2-3, 2014** and committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, laboratory and that it fulfills such other conditions required for proper functioning of the institution for **B.Ed. (Co-Ed)** course, as determined by the NCTE Regulations 2009.
- 4. Now, therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition SHRI SWAMINARAYAN B.ED COLLEGE, PLOT NO.1862, VILL/POST PRABHAS PATAN (SOMNATH TRUST) TEHSIL- VERAVAL, CITY-PRABHAS PATAN, DISTRICT JUNAGADH 362268, GUJARAT (Code No. WRCAPP213), for starting B.Ed. (Co-Ed) course of Secondary level of 1 year duration with an annual intake of 100 from the academic Session 2014-15.
- 5. Further, the institution is required to comply with all post-recognition conditions enumerated from clause 8(11) to clause 8(16) of the NCTE (Recognition, Norms & Procedure) Regulations 2009.
- 6. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.
- 7. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009 for the academic session **2014 2015**.
