**ORDER for Shifting of Premises**

Whereas, recognition was granted to the institution, Shri Shankracharya Mahavidyalaya, Shri Gangajali Education Society, Laxmi Narayan Temple, Sector- VI, Bhilai, Chhattisgarh for B.Ed course with an annual intake of 100 students vide order no. F.No.WRC/2-32/58/2004/2381-82 dated 19.04.2004 and for an additional intake of 100 seats vide order no. WRC/5-6/106th/ 2008/40547-40553 dated 29.08.2008.

And whereas, a revised recognition order no. WRC/APW0393/723004/2015/136179 dt. 20.05.2015 was issued for conducting B.Ed. programme of two years duration with an annual intake of 200 students (two basic units of 50 students each & Additional two units of 50 students each) from the academic session 2015-16.

And whereas, the Institution vide letter dt. 16.06.2012 submitted an application on 18.06.2012 for shifting of premises from Shri Shankracharya Mahavidyalaya, Shri Gangajali Education Society, Laxmi Narayan Temple, Sector- VI, Bhilai, Chhattisgarh to Shri Shankracharya Mahavidyalaya , Khasra No. - 97/2, Near Shri Shankaracharya Technical Campus, Beside Petrol Pump, Juniwani, Bhilai Nagar, Distt. - Durg, Chhattisgarh - 490020.

And whereas, the matter was placed before WRC in its 234<sup>th</sup> meeting held on November 03-05, 2015. The Committee decided to constitute visiting team.

And whereas, the inspection of the institution was conducted on 30.12.2015.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 242<sup>nd</sup> meeting of WRC held on February, 11-13, 2016 and committee decided to issue show cause notice.

And whereas, the show cause notice letter was issued to the institution on 18.02.2016, and reply of show cause notice was submitted by the institution on dt. 31.03.2016 .

And whereas, the reply of show cause notice was placed in 253<sup>rd</sup> meeting of WRC held on 24<sup>th</sup> - 26<sup>th</sup> May, 2016 and committee decided to issue clarification.

And whereas, the clarification letter was issued to the institution on 10.06.2016, and reply of clarification was submitted by the institution on dt. 02.06.2016 and 23.08.2016.

And whereas, the reply of clarification was placed in 261<sup>st</sup> meeting of WRC held on 26<sup>th</sup> - 28<sup>th</sup> October, 2016 and committee decided to as follows:-
