WHEREAS Recognition/Permission was granted to the institute **SHRI SAURASHTRA EDUCATION TRUST'S SMT. JAYSHREEHBEN NATUBHAI COLLEGE OF EDUCATION, VANTHALS ROAD, NEAR BILNATH TEMPLE, DIST. JUNAGADH-362001** under section 14 of NCTE Act, 1993 for conducting **B.ED** course with an intake of 100 from the academic session **2003-2004**; vide order No. **WRC/5-6/92/2006/12173-12180** dated **06.03.2007**

2. WHEREAS on the direction of the NCTE headquarters vide do letter No. 49-8/2008/NCTE (N & S) /78627 dated 21.05.2008 from NCTE, New Delhi directing WRC to conduct the inspection of 129 colleges of Gujarat u/s 17 of the NCTE Act 1993, as per the observation of Prin. A.U.Patel, the Chairman, fee/Admission Committee for self Finance B.ED/B.P.ED. course, Gujarat State & Formal Vice-Chancellor, Gujarat University. The Western Regional Committee had constituted a Visiting Team u/s 17 of NCTE Act, 1993 to Visit the institution.

3. AND WHEREAS, THE inspection of the institution was conducted on **06.06.2008**.

4. AND WHEREAS, the matter was considered by the WRC in its **104th** meeting of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-

1. **Built-up area (1185 sq. mts) is inadequate for running B.Ed. programme.**
2. **Principal is not qualified.**

5. AND WHEREAS the WRC directed that an opportunity be given the institution to make a written representation within 30 days from the date of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on **03.08.2008**.

5. AND WHEREAS the matter was again considered by the Committee in its **110th** meeting held on **November 12-14, 2008** and having taken into consideration all the relevant facts of the case, it was decided to withdrawn recognition for conducting **B.ED** course for the next academic session.

6. Now, therefore recognition to **SHRI SAURASHTRA EDUCATION TRUST'S SMT. JAYSHREEHBEN NATUBHAI COLLEGE OF EDUCATION, VANTHALS ROAD, NEAR BILNATH TEMPLE, DIST. JUNAGADH-362001** in terms of section 17(1) of the NCTE Act, 1993 is hereby withdrawn from next academic session on the following grounds.

1. **Land area is inadequate.**

7. Affiliating Body/ State Govt. are advises not to admit/ allot any student in **B.ED** in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or any State Government.

8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1- Bahadur Shah Zafar Marg, Near RTO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
