ORDER

Whereas, the recognition was granted to **Smt. Jayshree Ben Nathubhai College of Education, Sh. Suarashtra Education Trust, Near Bilnath Temple, C/o Ahir Kanya Chhtralaya Vanthali Road, Junagarh-362001, Gujarat** under section 14 (3) (a) of NCTE Act, 1993 for **B.ED** course from the academic session **2003-2004** with an annual intake of **100** students vide WRC order No. **WRC/2-32/49/2003/3443** dated **21.07.2003**.

And whereas, WRC decided to conduct inspection u/s 17 as per the direction of NCTE, HQ, New Delhi in June 2008. WRC considered the V.R in its 104th meeting held on July 19-21, 2008 and decided to issue show cause notice u/s 17 of NCTE Act vide letter no/38474-38475 dt. 27.07.2008. WRC considered the reply submitted by the institution in its 110th meeting and decided to withdraw recognition from academic session 2009-2010. Accordingly withdrawal order issued vide letter No.47926-47931 dated. 11.12.2008 on the ground that the "**Land area is inadequate**".

And whereas, institution preferred appeal u/s 18 of NCTE Act 1993 to New Delhi. The Appellate authority vide its letter No.89-29/2008-Appeal/92621, directed WRC that the institution should be re-inspected after six months to ascertain whether the required infrastructure in terms of built up area has been upgraded so as to conform to the NCTE norms. Accordingly, the council remand back the case to the WRC for re-inspection of the institution after receiving a fees of Rs. 40,000/- from the institution will continue as a recognized institution and to this extent the order of WRC has been reversed.

And whereas, VT was caused as per NCTE New Delhi direction and the inspection report alongwith other documents submitted by the institution was placed before the WRC in its 143rd WRC meeting held on 17th - 18th, Dec, 2010 and WRC considered the case of the institution and permitted to continue the recognition of the said institution with the same terms and conditions as mentioned in the recognition order dated 21.07.2003.

Now therefore, the recognition of said institution for **B.ED** course is hereby continue with the same terms and conditions as mentioned in the recognition order date 21.07.2003.
