ORDER

Whereas recognition was granted to VARDHMAN CHARITABLE TRUST, C/O LOKMANYA COLLEGE OF COMPUTER APPLICATION, 132, RING ROAD, SHIVRANJNI CROSS ROAD, SATELLITE, AHMEDABAD- 380015, GUJARAT under section 14 of NCTE Act, 1993 for conducting B.ED course vide order No.WRC/2-32/61/2004/4636 dtd. 15.07.2004 with an annual intake of 100 students.

And whereas, the recognition was withdrawn vide order No. No.WRC/APW00136/323093/123rd/2009/58813-58818 dt. 08.08.2009 as per decision of 123rd meeting of WRC.

And whereas, the matter was considered by WRC in its 145th meeting in the light of the Hon'ble Court of Gujarat at Ahmedabad in SCA No.3205/2009 and related matters and decided to cause inspection. The inspection of the institution was conducted on 20.05.2011. The VT report was placed in 150th meeting of WRC and the Committee decided to issue show cause notice on 21.06.2011.

And whereas, the reply submitted by the institution was placed in 153rd meeting of WRC held on 28th -30th, July, 2011 and the Committee decided to continue the recognition of the said institution with same terms and conditions as mentioned in the recognition order dt. 15.07.2004.

Now therefore, the recognition of said institution for B.ED course is hereby continue with the same terms and conditions as mentioned in the recognition No.WRC/2-32/61/2004/4636 dtd. 15.07.2004.
