ORDER

The Western Regional Committee of NCTE, vide orders dated 7.7.2003, passes u/s 14 of the NCTE Act, granted recognition to P. the NCTE Act, granted recognition to Ran Avdhoot Seva Mandal's Rang Avdhoot Adhvanan Mandir Mu Do Warral Mu Adhyapan Mandir, Mu. Po. Vasna-Margia, Taluka and District Kheda - 387120 Gujarat and allowed annual inteles of 50 and allowed annual intake of 50 students in PTC course from the academic session 2003-2004. The formal order of recognition was issued to it on 10.11.2004 with the express condition that it shall complete it. condition that it shall comply with the norms and standards prescribed by NCTE for conducting the PTC Jourse.

The State of Gujarat, vide letter dated 13.1.2005, informed the NCTE that the institution had not been conducting the course properly. It was stated that, on 5.1.2005, the District Education Officer, Kheda, visited the institution and, after hearing all the concerned parties, reported as many as 18 misconducts. This report was duly considered by the Director of Primary Education and forwarded to the State Government. The State Govt. also agreed and requested the NCTE to withdraw the recognition.

The WRC, NCTE examined the documents in its 68th, 75th, 76th 77th and 78th meeting. On being satisfied about the contraventions of prescribed norms and standards on the points enumerated below, it decided to issue the show cause notice dated 24.10.2005 giving three weeks' time to the institution to show cause u/s 17(1) of the NCTE Act as to why the recognition be not withdrawn for the following contraventions of prescribed norms and standards:-

1. The management failed to fulfil the conditions required for proper functioning of the institution. It was not able to stop the vulgar dance programme arranged by trustee's son in college campus during Christmas Vacations of 2004 which embarrassed the girls residing in the hostel.

The management was not able to stop the recovery of illegal funds by the employees of the institution and the son of the trustey 2.

3. The managing trustee and his son were facing investigations by Police Station Mehemdabad for committing offences under sections 342, 509, 114 of the IPC and under sections 3(1), 3(10) and 3(1)(2) of the Atrocities Act for the aforesaid criminal activities and indecent behavior in the college campus.

In writ petition, SCA 1003/2005, pending before the Hon'ble High Court of Gujarat at Ahmedabad, the Hon'ble Court also took cognizance of the above incidents and compelled the management to refund the sum of Rs. 8,28,931/-The students were also pursue their studies in other recognized PTC institutions.

The institution submitted its written representation dated 10.11.2005 which was not supported with any kind of documentary evidence. The matter was placed for the consideration of WRC, NCTE in its 85th meeting held on July 13-14, 2006.

May Pallonia Comuli dos Textes -The WRC considered the explanation given by the institution in its written representation. It was found that the institution simply denied the incident of vulgar dance and the allegation of recovery of funds. Regarding the police investigations, it was stated that the FIR was cooked up. Regarding the SCA 1003/2005, it was stated that the institution had complied the court orders. The WRC, NCTE did not accept the denial of the institution in view of the enquiry conducted by the District Education Officer, Kheda. The institution did not raise any mala-fide intentions against the said government official. There was no reason to disbelieve the DEO when his report was duly examined by the Director of Primary Education as well as the State Govt. When all concerned authorities were satisfied about the above contraventions, there could be no occasion to believe the simple denial of the institution.

Consequently, the Western Regional Committee of NCTE, in exercise of its powers u/s 17(1) of the NCTE Act, directed the undersigned to inform the institution that its recognition to conduct the PTC course stands withdrawn with effect from the end of the academic session next following the date of communication of this order.
